Dear Director Weeks:

I am in receipt of your waiver request of the class size average found in Tenn. Code Ann. § 49-1-104 for one fourth grade class at White House Heritage Elementary in Robertson County Schools.

The commissioner's waiver authority under Tenn. Code Ann. § 49-1-201(d) is limited by Tenn. Code Ann. § 49-1-104(a), which states that "neither the commissioner nor the state board of education shall grant waivers from the maximum class sizes established in this section."

With the understanding that the fourth grade class at White House Heritage Elementary will not exceed the maximum number of students per class specified in the above referenced law, your request for a waiver of the class size average is hereby granted for the 2025-26 school year.
