Please find the attached summary review of findings from the School Nutrition Program's 2022-23 fiscal year administrative review of Lake County Schools' National School Lunch Program and School Breakfast Program. This review was conducted the week of November 28, 2022, with the exit date of November 30, 2022. The attached summary includes the identified findings and the corrective actions required.

District responses and supporting documentation of corrective actions are required for all findings, and findings must be corrected district wide. The School Nutrition Program director must provide the responses to the findings via the Tennessee: Meals, Accounting, and Claiming (TMAC) system in the "Compliance" section, as discussed with the lead reviewer. Technical assistance areas do not require responses; these suggestions are only to help the district improve the program. They are also available in the "Compliance" section in TMAC.

All corrective actions shall be documented and supported in the "Compliance" section in TMAC no later than December 30, 2022. During this timeframe, if you identify errors or points of disagreement in our findings, please contact me to discuss next steps. If there are no errors or points of disagreement, please be mindful that refusal or failure to comply with the required, corrective actions within the allotted timeframe may result in fiscal action.

Upon receipt of Lake County Schools' documented corrective actions, the Tennessee Department of Education will determine whether the documentation is complete and resolves the findings identified. Once the department approves the corrective actions, your district will receive a closure letter closing the review within 30 calendar days.

| 1400 - Food Safety | V-1400 | Observed that thermometers were not calibrated properly, and the correct thermometers were not used to measure the temperature of hot and cold food. | Provide additional thermometers for this site. These thermometers must be capable of measuring temperatures below 50 degrees Fahrenheit and calibration with the ice-bath method. Train all cafeteria staff in the proper use and calibration of thermometers using the ice-bath and boiling-point methods as appropriate. Upload proof of purchase or pictures of the thermometers to demonstrate compliance. Upload a training agenda and sign-in sheet to demonstrate compliance. |
