Please find attached the summary review of findings from the School Nutrition Program's 2016-17 fiscal year administrative review of Greene County's National School Lunch Program, School Breakfast Program and Afterschool Snack Program. This review was conducted the week of March 13, 2017, with the exit date of March 17, 2017. The summary includes the identified findings and the corrective actions required.

District responses and supporting documentation of corrective actions are required for all findings, and findings must be corrected district wide. The School Nutrition Program Director will provide the responses to the findings via the Tennessee: Meals, Accounting, and Claiming (TMAC) system in the "Compliance" section, as discussed with the lead reviewer. Technical assistance areas do not require responses; these suggestions are only to help the system improve the program. They are also available in the "Compliance" section in TMAC.

During the review, findings in section **100: Certification and Benefit issuance and 1700: Afterschool Snacks require** fiscal action. An explanation of the findings is included in the attached review summary. All corrective actions for Greene County shall be documented, supported, and listed in the "Compliance" section in TMAC no later than April 21, 2017.

If you find errors or points of disagreement in our findings, please contact me, and I will assist you with your next course of action. If there are no errors or points of disagreement, please be mindful that refusal or failure to comply with the required corrective actions within the allotted timeframe may result in further potential fiscal action.

Upon receipt of Greene County's documented corrective action, the Tennessee Department of Education will determine whether the documentation is complete and resolves the findings identified. Once the department approves the corrective actions, your district will receive a closure letter closing the review within 30 calendar days.

There were also eleven applications with social security errors. Upload a copy of the notification letter sent to households of miscategorized and missing applications.
1600 - School Breakfast and SFSP Outreach	V-1600	Families were not informed of the availability and location of free summer meals.	Make families aware of the availability and location of free summer meals. Create and upload a summer meal outreach document that will be provided to families.
700 - Resource Management	V-0700	Starting balance and income from 2015-16 Financial Report did not match the income and fund balance (as of July 1, 2016) in the 2016 State of Tennessee Comptroller's Annual Report for the County	Investigate why there is a discrepancy. Once the discrepancy is resolved, contact the School Nutrition central office. Upload documentation necessary to prove resolution.

1700 - Afterschool Snack	V-1700	Afterschool snack requirements were not being met. There are no counts for February.	Begin keeping snack counts immediately. Upload one month of completed afterschool counts as documentation of compliance.
