

2024-25 State Report Card Review and Appeals Instruction

The 2024-25 State Report Card will go live on December 18, 2025. The State Report Card review and appeals window will take place from Tuesday, December 2 to Monday, December 15, 2025. The appeals process and access instructions are explained below. Districts may also reference the November 21, 2025 State Report Card Preview and Appeals webinar recording and slidedeck on the Accountability application's announcement page.

Access and Appeals Instructions:

Directors and Report Card contacts may access the State Report Card dashboard by navigating to https://tdedistschools.ondemand.sas.com. Users will sign in with state SSO credentials. If needed, access for additional district leadership may be requested by emailing Report.Card@tn.gov.

The State Report Card populates data from multiple data sources, requiring appeals to be submitted via multiple forms. Table 1 details the appealable data for the 2024–25 State Report Card release, as well as the correct submission form for each data type. Table 2 lists all non-appealable data for the Report Card dashboard. Note that some data displayed on the dashboard was finalized during previous appeal windows.

Submission deadlines are detailed in Table 1 and vary based on the data type. Appeals received after the submission deadlines will automatically be denied.
