SUBJECT: 2022-23 Annual Safe Schools Report

The Schools Against Violence in Education (SAVE) Act of 2007, now codified as T.C.A. §§ 49-6-801-818, provides that the Commissioner of Education and Commissioner of Safety & Homeland Security annually report to the Governor and General Assembly on implementation of the Act. Additionally, T.C.A. § 49-6-4301(e) requires the Commissioner to report on "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel."

This report provides a summary of serious incidents occurring within Tennessee schools during the 2022-23 school year, as well as an overview of efforts currently undertaken to ensure the safety of our students and staff.

Executive Summary

T.C.A § 49-6-810 requires the Commissioner of Education and Commissioner of Safety & Homeland Security to report annually to the Governor and General Assembly on implementation and compliance with the Schools Against Violence in Education (SAVE) Act. Additionally, T.C.A. § 49-6-4301(e) requires the Commissioners to report on "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel."

In May 2022, Governor Bill Lee signed Executive Order 97 and initiated an Enhanced School Safety Working Group comprised of leaders within the Tennessee Department of Education (TDOE), Tennessee Department of Safety and Homeland Security, Tennessee Department of Mental Health, Tennessee Department of Commerce and Insurance, Tennessee Emergency Management Agency and the Governor's Office. This group meets monthly to determine action steps to improve school safety across Tennessee. Action steps have included developing more resources for parents to engage in school safety, increased trainings for schools on safety best practices, refinement of emergency operation plan templates and increased coordination with local law enforcement.



Emergency Preparedness

Emergency Operation Planning

The SAVE Act, passed in 2007, established specific and consistent requirements for districts related to providing a safe school environment, including the formation of district and school safety teams and requirements for the development of comprehensive safety plans. These plans, referred to as emergency operation plans (EOPs), outline how schools prepare for, respond to, and recover from emergencies. A well-developed and well-documented EOP ensures that plans and procedures are comprehensive and are communicated to everyone with a potential role during emergency situations.

It is important to note here the difference between a district and a school EOP. District EOPs set the stage for school-level EOPs by providing standards and, where appropriate, uniform response protocols. District EOPs also ensure that adequate and appropriate planning occurs with the broader school community and that district-level resources will be directed to support schools when needed. School-level EOPs provide the individually tailored planning, support and direction needed to address the unique needs of each school.

District and school EOPs are reviewed on a five-year cycle that coincides with their county emergency management planning cycle. EOP reviews are conducted using an evaluation rubric that is aligned with EOP requirements identified in T.C.A § 49-6-805.

During the 2022-23 school year, 26 district EOPs were reviewed with the following findings:

Conducting Emergency Drills

Training on school safety principles provides school personnel techniques for identifying strategies to prevent or mitigate threats and hazards, respond to emergencies and to ultimately recover from a crisis. Students are trained on emergency procedures, and emergency drills provide an opportunity to identify gaps in the training. The current drill requirements for schools are outlined in the table below:

Drill	Description
Fire Drill	Fire drills requiring full evacuation shall be held at least one (1) time every thirty (30) SCHOOL DAYS , with two (2) fire drills occurring during the first thirty (30) full days of the school year. Additionally, four (4) fire safety educational announcements will be conducted throughout the year. T.C.A. § 68-102-137(b).
Intruder Drill	Each school shall conduct at least one (1) armed intruder drill annually. The drill shall be conducted in coordination with the appropriate local law enforcement agency. T.C.A. § 49-6-807.
CPR/AED Drill	Each school having one (1) or more AEDs shall schedule annual CPR/AED training for junior and high school students and conduct an annual CPR and AED drill. T.C.A. § 49-6-1208.
Additional Drills	Each school shall conduct three (3) additional drills, not requiring full evacuation, during each school year. T.C.A. § 68-102-137(f).
	Each school administered by a local education agency (LEA) having jurisdiction that lies entirely or partially within 100 miles of the New Madrid Fault Line shall conduct at least two (2) earthquake preparedness drills

In addition to reviewing EOPs, drill logs from the 2021-22 school year were also reviewed. A total of 255 drill logs were reviewed during the most recent review cycle indicating the following:

School Resource Officers

The 111th General Assembly amended T.C.A § 49-6-809 to prioritize the placement of school resource officers in Tennessee schools. For FY20, the General Assembly appropriated an additional \$20 million in one-time Safe Schools funding to support the placement of school resource officers (SROs) in schools across the state that did not have a full-time officer in place during the previous school year. The intent of this one-time grant was to assist local governments until they could sustain their SROs with their own funding sources.

During the 2019-20 school year, the Department awarded \$7,466,700 for 213 new, full-time SROs in 58 LEAs. The 58 LEAs awarded funding during the 2019-20 school year were allowed to apply for a second year of funds and 52 of those LEAs reapplied. During the 2020-21 school year, the Department awarded \$6,881,378 to support 197 school resource officers during the 2020-21 school year. Six LEAs did not reapply as their partner law enforcement agency was unable to recruit or place an officer within the current pandemic environment. During the 2021-22 school year, the Department awarded \$6,727,526 for 190 school resource officers in 52 LEAs. During the 2022-23 school year, the Department awarded 3,003,050 for 188 school resource officers in 52 LEAs.

The Department will continue to work closely with the Department of Safety and Homeland Security to identify strategies to increase SRO placement with grant funds. Information about school resource officer grant funding can be found in <u>Appendix I.</u>

The table below reflects a six-year trend in the number of SROs and the percentage of SROs at each grade band in schools.

School Safety Grant Programs

The Department currently administers two grant programs to support school safety—the Safe Schools Grant and the School Resource Officer (SRO) Grant.

Grant Program Overviews

Safe Schools (Recurring)

- Purpose: Districts were required to use the results of a school security assessment developed by
 the Department of Safety and Homeland Security as a needs analysis to drive the use of grant
 funds. Alignment with identified needs is validated during the grant approval process. Information
 about district level funding, including how these funds are being utilized can be found in Appendix
 II.
- **Awards:** Grants were awarded to all districts in proportion to their relative share of the education funding formula. Districts are required to provide a 25% local match that is adjusted for fiscal capacity.

Appropriations:

- o FY18: \$4.8M in recurring funding
- FY19: \$10M in recurring funding
- FY20: \$20M in recurring funding
- FY21: \$20M in recurring funding
- o FY22: \$20M in recurring funding
- FY23: \$20M in recurring funding

SRO Grant (Non-Recurring)

- **Purpose**: Grant funds were limited to supporting the placement, training, or equipment for full-time SROs in schools that did not have a full-time SRO in the prior year. Information about district level funding can be found in <u>Appendix I</u>.
- **Awards:** Any Tennessee school district may apply. Grants are in the amount of \$35,000 per SRO and require a 25% local match that is adjusted for fiscal capacity. During the 2022-23 school year, the third year of SRO grant funding, only prior year grantees could reapply for a reduced funding

rate of \$14,187.48 per SRO as compared to the \$35,000 per SRO in prior years. Due to the reduced rate, a local match was not required.

• **Appropriation:** The grant program was set up for three years with the non-recurring FY20 appropriation of \$20M in Safe Schools funding. Both grant program years are supported with this one-time appropriation.

Grants to States for Emergency Management (GSEM)

The Department is using the GSEM grant to expand their capacity to assist LEAs in the development and implementation of high-quality emergency operations plans (EOPs) through the following objectives:

Objective A: Expand training and support to LEAs through staffing infrastructure within the Department, as well as contractual support to enable the Tennessee School Safety Center to transition to a force multiplier model via the use of training of trainers to reach a larger and more diverse target population.

- The Office of School Safety and Transportation issues a monthly newsletter to all Safety
 Coordinators in each district across the state and to those who subscribe. We also have 8 School
 Safety Mentors who are trained trainers in developing high-quality EOPs, reunification,
 psychological and emotional recovery, PREPARE postvention, active shooter training and threat
 assessment. This year they have attended trainings from Safe and Sound Schools to include:
 - National Summit on School Safety
 - Midwest School Safety Summit
 - o TN Virtual School Safety Summit
 - o Southeast School Safety Summit
- The mentors have provided technical assistance in the areas of EOP Development, Threat
 Assessment Consultation, Memorandum of Understanding, PREPARE Postvention, SRO trainings,
 standards, qualifications and best practices, access and functional needs, National Incident
 Management Systems reunification, signs and symptoms of mental health challenges in youth and
 restorative practices.

- **Training Evaluations** (total of 440 participant surveys) indicate the following:
 - 97.5% Strongly Agree or Agree that the training session covered information they anticipated learning.
 - 96.8% Strongly Agree or Agree that the training session enhanced their knowledge and/or skills.
 - 98.4% Strongly Agree or Agree that the instructor's presentation skills were approachable, clear and effective.
 - 99.5% Strongly Agree or Agree that the instructor demonstrated knowledge of the material presented.
 - 97.9% Strongly Agree or Agree that they think the training would be beneficial to others in the future.
- **Comments** from the training evaluations include the following:

Additional trainings available included:

• If I Had A Dime: Hindsight to Foresight for Today's Leaders presenter C.J. Huff (1 hour)

- o In this session, Dr. C.J. Huff, retired superintendent from Joplin, Missouri shares his very personal recovery and leadership journey following the May 22, 2011, tornado that destroyed much of his school system and implications for leaders. He states if he had a dime for every time he said, "You gotta take care of yourself before you can take care of others!" He would have been able to rebuild his entire community after their disaster. Attendees will leave this session with practical strategies and an understanding of the "3 Pillars" that serve as the leadership foundation for career sustaining behaviors that can make a difference in the mental health and wellness of not only yourself, but those you lead.

Bright Futures presenter CJ Huff (.5 hour)

- Or. C.J. Huff, superintendent of Joplin Schools had a problem in spring of 2010. He was tasked with getting the graduation rate up. Like so many communities across the nation, many Joplin students struggle with poverty and often a lack of parental involvement. Teacher spent much of their time and often their own money trying to meet student's basic needs. Low graduation rates were identified as a community issue and not just a school issue. This session will discusses the community efforts to ensure it's citizens flourished and thrived.

- "I like the idea of connecting our students to mentors, community service-learning partners and having opportunities to work in apprenticeship programs."

Panel Discussion on School Safety presenters Safety Mentors: Greg Wallace, Tad Roberts, Mandy Schneitman, Kristi Brown, Jeff Hicks and C.J. Huff (1 hour)

- o In this session, participants will meet our school safety mentors across the state and learn about their unique skills and their experiences in school safety. Participants will see safety from the lens of mental health, law enforcement, student support services, and transportation. They indicate the need for training all staff in emergency operation planning, behavioral threat assessment and reunification as well as a need for informing parents and community of safety procedures in place to ensure their child is safe at school. The emergency operation plan should not just be a checklist that only lives on the shelf. It should be a living document that is built and revised by all key stakeholders. The key to building safety plans is building relationships with the key stakeholders. Students and parents need to have an anonymous reporting system to report concerns. They discuss the importance of moving beyond compliance to being prepared for all emergencies. The key takeaways from this session are to prepare, train, and practice emergency operation plans and procedures.
- o 443 total evaluations
 - 95% Strongly agree or agree the session enhanced their knowledge of skills.

- 98% Strongly agree or agree the presenter demonstrated knowledge of the material presented.
- 95% Strongly agree or agree they think the training would be beneficial to others in the future.

o Comments:

- "I appreciated their focus on prioritizing."
- "I always enjoy listening to a panel discuss important topics. This one in particular was informative. One of the panel members made a comment that has resonated with me. She said that emergency planning is not an option, it's non-negotiable."
- "The panel stressed the importance of working with the community, janitors, nurses and all. We are reminded that our emergencies are not all intruders, but fires, storms and other disasters. We were also reminded that these emergencies didn't just happen in the school building, but on buses and elsewhere."

Resilience Through Tragedy: The Humphreys County Flood Experience presenters Kristi Brown and Michele Gay (1 hour)

County Schools, talks about the August 21, 2021 flooding. On this Saturday morning, the community did not realize how bad the flash flooding was going to be. The water rose so rapidly, the town was not recognizable in a matter of minutes. Over 400 homes were damaged or destroyed, 20 lives were lost, 2 schools and the fleet of school buses were lost and the central office was heavily damaged. Football fields and athletic fields were also destroyed. Staff had lost their housing or lost loved ones. Humphrey's County Schools knew the importance to getting back to normal and the importance of resiliency. They have learned to be flexible and have grace with one another to get back to the work of educating students. They lost their paper student and staff records and learned that in the future it is important to have an electronic backup of records. She discusses how to communicate when the community is in crisis and executive functioning is not at it's best due to the trauma experienced. She also talks about the process of working with FEMA to rebuild. She talks about the importance of having mental health services available for the recovery process.

414 total evaluations

They realized students and parents needed the stability that schools give. "Psychological impact of this is huge"- This is so true!! It is just wonderful how so many different counties and support agencies jumped in there to help. So thankful this was on a Saturday morning and not on Friday when kids were at school. Still a long way to go but very

resilient. Support from others helps with that resilience. Essentials: Plan in advance (multiple backups of inventory-pictures), let process work, waivers, patience."

• Emergency Communications presenter Mandy Schneitman (1 hour)

- o Safety Mentor Mandy Schneitman talks about how the school emergency response team or SERT team is responsible for developing, monitoring and adjusting the school emergency operation plan communication procedures. It is important to note that the school emergency operation plan communication procedures do not stand alone but require collaboration with the district's emergency operation plan communication procedures. She also indicates the need for school communication procedures to have redundant and backup methods which mut be trained and practiced evaluating their effectiveness. Timely communication saves lives. It is important to consider how staff will communicate safety concerns, emergencies, during school and after school hours. Will they be able to initiate the emergency operation plan procedures? She also talks about communication with students and staff through the functional procedures of evacuation, get inside, hard lockdown and soft lockdown, shelter in place due to weather, shelter in place due to hazardous materials exposure. External communications with the 911 center, district office, parents/families, transportation, unified command and the reunification site are also important. Things to consider include considering the methods to communicate with parents and families and having prepared scripts to follow in messaging to save time and be consistent. You want to set a rhythm to communicate with parents. It is important to practice it with your drills.

- "This video shared essential information that is so important for a county to be fully prepared to work through the steps of an unforeseen emergency. Very thorough information. My hope is that all counties in the State of Tennessee prepare for what could possibly happen and not believe it won't happen."
- "I appreciate how much she stressed practicing as well as having the EOP as a living document."

School Climate and the Connection to School Safety presenter Kimberly Daubenspeck (1 hour)

o Participants will learn about the impact of school climate on school safety and best practices for improving school climate and safety to include signs and symptoms of mental health challenges and best practices for responding to those challenges, social and personal competency and restorative practices concepts, and tips for enhancing school safety using a behavioral threat assessment model. Best practices for improving school climate rely on building strong relationships among students, staff and families. The key to improved school safety is through relationships. The only way you will know a student is on

the pathway to violence is through relationships and the only way you will be successful in getting a student off the pathway to violence is through relationships.

"This video is a good reminder to connect regularly with students, staff and administrators to promote a healthy and positive School Climate. The links, apps and information is useful and accessible. The connection: school climate school safety (and personal safety) is evident, not only from this session but all sessions included in this TN Virtual School Safety Summit. Fostering connection is critical in creating a healthy and positive school climate."

• The Impact of Mental Health presenter Greg Wallace (.5 hour)

- Greg Wallace, Supervisor for School Safety and Mental Health at Johnson City Schools talks about mental health trends that he has seen in schools over the years. He tells his story of his educational experiences growing up in poverty and homeless. He talks about managing the Safe Schools Health Students federal grant to infuse law enforcement and mental health safety measures in schools in 2008 to 2013. He addressed ensuring there is a stronger school counselor and mental health presence in schools which allowed services to be provided directly at the school. This eliminated the barrier parents had in getting their child to the counseling services. Also, when the school builds behavior and support plans, they can ensure the mental health services participated in the planning. At the time, in Johnson City, 20% of students were in need of mental health services. The program saved lives in providing services to students who were suicidal. The district has sustained and grown the program since the grant ended. He is now thinking about how to serve students how may need tier 4 support in Response to Intervention for Behavior. He also talks about how behavioral threat assessment has been incorporated into the program by training staff, providing school-based threat assessment teams that work cohesively with the mental health services already in place. He calls them his care teams. They meet once per week to discuss concerns, identify supports and evaluate the effectiveness of those supports. Johnson City Schools decided that training staff in behavioral threat assessment would be a priority. He discusses issues such as making sure people understand that threat assessment is not just a punitive process, supports will be provided. He talks about this importance of collecting all of the dots before you connect the dots. You will not have a good plan in place if you do not collect all of the dots.

- "I believe it's important that schools don't minimize the importance of mental health presence in schools. I love the thought of having a "mini clinic" in schools and using behavior threat assessments as a preventive measure and not a punitive measure."

• Ready to Respond: Key Takeaways from a Tragic School Bus Accident presenter Tad Roberts (.5 hour)

- o Tad Roberts, Supervisor of Safety and Social Services and Transportation, tells lessons learned from the Meigs County tragic bus crash on October 27, 2020 at 3:45 p.m. 1 driver and 33 elementary and middle school students were on the bus that day when a utility truck hit the bus. There was an SRO behind the bus at the time of the crash. Student accountability was important because the roster that was readily available on the bus was damaged in the crash. They relied upon mutual aid of other county first responders. 5 students were air lifted and 2 lives were lost, the bus driver and a student. School Counselors and staff went to the hospitals to be with the students. Reunification had to be started. Another bus picked up the students to take them back to school for reunification. Tad also talks about the NTSB findings of the bus crash. He also talks about the importance of preparing our rolling classrooms through conducting bus inspections, testing communications equipment and building emergency go kits. It is important to have multidisciplinary teams to develop emergency operation plans for buses and to train on the plan with bus drivers, students and parents and continue to practice or exercise the plan. Not all students ride on the school bus on a regular basis and my only ride for field trips, so how can we make sure all are trained. The key takeaways are to prepare by conducting and documenting all trainings, exercises and evaluations, maintain records of drivers and buses. Also, to respond by providing back-up transportation, communicating with parents and media, collecting and releasing personal property, tracking medical status and store and dispose of the crashed bus. Finally, for recovery, identify needs for continuity of operations, conduct briefings and provide support services and provide after action review and support ongoing investigation. Everyone deals with trauma differently. It is important to be aware of how people are coping and provide support accordingly. Long term support and flexibility of services is important. Many drivers had survivor's guilt. Trust the investigation process.

• Bullying Prevention Practices presenter Kimberly Daubenspeck (.5 hour)

- In this session, participants will learn about best practices to prevent and respond to bullying to include establishing a safe learning environment, defining bullying, warning signs and symptoms of bullying, and prevention practices and programs. Informational sheets for parents and educators will also be shared.
- 454 total evaluations
 - 96% Strongly agree or agree the session enhanced their knowledge of skills.
 - 97% Strongly agree or agree the presenter demonstrated knowledge of the material presented.
 - 96% Strongly agree or agree they think the training would be beneficial to others in the future.

• Saving Sycamore presenter Molly Hudgens (1 hour)

- Molly Hudgens, a school counselor in Pleasant View, Tennessee, tells her story of averting a school shooting when an eighth grader, armed with a semi-automatic handgun and an additional magazine of ammunition, came to her in the counseling department at Sycamore Middle School on September 28, 2016. In this session, participants will learn about how Hudgens was able to convince the student to relinquish the weapon to her with no shots fired and no lives lost.
- o 592 total evaluations
 - 98% Strongly agree or agree the session enhanced their knowledge of skills.
 - 99% Strongly agree or agree the presenter demonstrated knowledge of the material presented.
 - 98% Strongly agree or agree they think the training would be beneficial to others in the future.

- "This one brought tears of joy, sadness, etc. I am honored to be a school counselor and only pray I would be able to be as strong/helpful as she was."
- "I would love to show this to a room full of educators and see their reactions. Or, even better, a group of people interviewing for educational careers (working with young people). For the most part, people "moved" or effected by the video, probably a good hire."
- "Molly Hudgen's experience entitled "Saving Sycamore" was beyond powerful, insightful, and informative. I am beyond impressed with her handling of the situation, both professionally and personally. In that moment, she was in touch with her senses, impulses and shear human nature. Her previous experiences by being encouraged to participate in writing an emergency plan (active shooter plan), reading and researching about many unfortunate school shooting incidents, helped to provide her valuable information in dealing with the situation that she faced that September morning. It's in sharing, that we all as professionals grow. As a teacher, I

am grateful for the experience to watch the TN Virtual School Safety Summit Sessions. I pray that we all never experience violence, hate, anger, fear, and any other problems that might escalate a situation into a fatality at school. However, it is in being prepared, having plans in place, being able to execute a plan in an emergency situation, building relationships in our community (school and beyond) and having good support systems in place, that we can be successful in coming to a peaceful resolution. Again, I am reminded that truly, our teachers and counselors that enter our school buildings everyday are MORE than just those simple titles. Molly Hudgen's you are a HERO and an inspiration. Thank you for sharing your story."

Objective B: Create training, curriculum and technology supports that enable LEAs to effectively monitor and support the development of building level EOPs.

- The Department has executed the procurement of the Safety Training Curriculum Development and Delivery contract with the following objectives:
 - Training curriculum based on national and state policy and best practices in a variety of
 formats to include an instructor guide for the school safety mentors to present from. These
 trainings will enable district level and school level administrators as well as school level
 staff to understand their role in school safety, security, intervention, prevention, and
 emergency preparedness planning.
 - 2. Continuation and improvements to the Tennessee School Safety Mentor Program, which represent diverse areas of expertise, located throughout each grand division, who will be available to assist districts in meeting needs identified through the security assessment and compliance monitoring processes in place or currently being developed.
 - 3. Revision and launch of the Tennessee School Safety Specialist (TSSSP) program which incorporates the elements described above and is focused upon establishing a cadre of trained school personnel across the state.
 - 4. Training evaluations aligned with established state and federal training evaluation and reporting requirements.
 - 5. It is the Department's intent that the three support elements identified above interface in such a way as to support the broad dissemination of best practices in school emergency operations and long-term sustainability.

Objective C: Define the role of the school resource officer and the first responder community in assisting schools in the development of building-level EOPs and develop training and resources to support that role.

- The Department entered into an Interagency Agreement with the University of Tennessee Law Enforcement Innovation Center from July 1, 2021 to June 30, 2022 that had the following objectives:
 - Develop a 40-hour basic training for new SROs that includes:
 - School Resource Officer Overview and Leading Practices
 - Engaging the School Community
 - Current Trends in School Crime and Contributing Factors
 - Legal Aspects
 - Special Education
 - Memorandum of Understanding
 - School Building Security, CPTED, and Leading Practices
 - Emergency Operations Planning
 - Risk Management for After School and Interscholastic Athletics
 - Student Supports
 - Multi-Tiered Systems of Support for students
 - Adverse Childhood Experiences
 - Mental Health Challenges and Suicide Prevention
 - School Climate and Culture

- Bullying Response and Prevention
- Restorative Practices
- De-Escalation Tips
- Averting Targeted School Violence and Threat Assessments
- o Develop a 16-hour training for annual training for all SROs that includes:
 - Restorative Practices
 - Youth Mental Health First Aid
 - Trauma Informed Practices
 - Threat Assessment
 - CPTED
 - Emergency Operations Planning
 - Transportation Safety Planning
 - Security Assessments
- The Department has provided the 40-hour training to Tennessee Law Enforcement Training Academy (TLETA) to implement new SROs as Governor Lee and the General Assembly have set aside funds to ensure every school has an SRO.
- The Department has received approval for the following trainings to satisfy the 16-hour annual training for SROs to be POST Approved:
 - TN Virtual School Safety Summit (13 hours)
 - o Youth Mental Health First Aid (6.5 hours)
 - Restorative Practices (7 hours)
 - Building Strong Brains (6 hours)
 - Averting Targeted School Violence (1.5 hour)
- Safety mentors attended TNSRO June 12-16, 2023 to provide support and resources to SROs.

Objective D: Research best practices and develop a framework or template for integrating student transportation operations into district and school-level EOP processes and create training resources for transportation supervisors and drivers.

- The Department is in the process of developing a Student Transportation Safety Plan to include the following:
 - Preparedness
 - Inspections
 - Communications
 - Emergency Kits
 - Emergency Drills
 - Response
 - Functional procedures to include shelter in place, drop cover and hold, evacuation procedures, and student accountability and release procedures.
 - Threats and hazards to include critical medical emergency, non-critical medical emergency, bus transfer, fire, collision or crash, and downed power lines.
- The school safety contract will include the development of training for bus drivers that is aligned with the student transportation safety plan.

Objective E: Maintain a partnership infrastructure that will facilitate collaboration and ensure sustainability beyond the grant period.

- The Department has developed a formal relationship with the Department of Commerce and Insurance to ensure accountability of our drills.
- The Department has developed a formal relationship with Tennessee Emergency Management Agency to collaborate on emergency preparedness for schools and to coordinate response for school emergencies.
- The Department has developed informal relationships with Tennessee Department of Safety and Homeland Security for development, training and monitoring of school security assessments.
- The Department has developed informal relationships with the Tennessee Department of Health and Tennessee Department of Mental Health for the development of resources and information.

Transportation

Since implementation of T.C.A. § 49-6-2116, the Department has hired a director and a consultant to oversee training and monitoring associated with the district transportation requirements. The Department's transportation staff are responsible for overseeing support in training and compliance, and for recommending school bus specifications. Significant accomplishments in this area include:

- **Training.** Transportation supervisor training guidance has been developed and shared with LEAs to clarify the training process and supervisor obligations. Student Transportation Management Training has been developed and is currently being offered as on-demand courses for transportation supervisors. All supervisor training is being tracked and certified.
- **Compliance.** A monitoring system is in place to ensure compliance with state and federal pupil transportation requirements. To date, 115 compliance visits have been completed.
- **Specifications.** The Tennessee State Board of Education approved updated school bus specifications based on the Department's recommendations on September 18, 2019.
- **Bus Driver Shortage.** In 2022, the Department conducted a bus driver shortage study. This study included the collection of 60 data points from 122 transportation supervisors, 5 in-person listening sessions, and the development of 13 strategies to help districts mitigate the impacts of their driver shortages.

In addition, the Department is currently administering a \$3 million appropriation to establish a school bus seat restraint grant program. The program reimburses districts for the additional cost associated with adding seat restraints when purchasing new buses or retrofitting qualifying buses already in operation. Nineteen districts have been awarded grant funding to place 102 buses in service that are equipped with seat restraints.

Additional information regarding Tennessee's student transportation system and the seat restraint grant can be found in <u>Appendix III.</u>

School Safety Index

Serious incidents related to student behavior in Tennessee schools are tracked via the Department's student management information system. For the purposes of this report, the Department has developed a measure entitled the School Safety Index which includes those serious incidents deemed to be most directly related to the safety and welfare of students, including the following:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device
- Possession of a weapon other than a firearm
- Assault of a teacher or staff member
- Assault of a student
- Sexual assault
- Aggravated assault of a teacher or staff member
- Aggravated assault of a student
- Attempted homicide
- Bomb threat (new)

The table below indicates serious incident totals for school years 2018-19 through 2022-23. Due to the significant reduction in the number of days in which students were on campus because of COVID-19 school closures, the data demonstrates a reduction in serious incidents. For that reason, the 2019-20 and 2021-22 data are not comparable.

To arrive at a school-level measure, the total number of the above incidents that have been reported for the school year via the student management information system are divided by a school's average daily

membership (ADM) to arrive at a school safety index score. Scores for any schools reporting one or more serious incidents during the 2022-23 school year, aggregated by school district, are included in Appendix IV.

Using the same formula (i.e., serious incidents/ADM) to review Tennessee as a whole, the aggregate school safety index for Tennessee is presented below. Again, due to the significant reduction in the number of days in which students were actually on campus as a result of the COVID-19 pandemic school closures, 2019-20 and 2020-21 data is not comparable.

Road Ahead

As the Governor's Enhanced School Safety Working Group continues to meet, school safety will continue to be a priority. A particular focus for the 2023-24 school year includes school climate, trainings, and supporting school resource officer programs. Specific steps currently being taken include:

- 1. Develop and provide training and technical assistance on school climate and its relationship to safety to include threat assessment.
- 2. Develop new content for upcoming school safety trainings.
- 3. Ensure School Resource Officers (SRO) are well-trained and compliant with T.C.A. 49-6-4217.

Appendix IV: 2022-23 School Safety Index

Description: T.C.A. § 49-6-4301 states that "the commissioner shall report to the governor and the General Assembly concerning the prevalence of violent and disruptive incidents in public schools." To fulfill this legislative mandate, the Department has developed the School Safety Index. For each school, the reported sum of serious school safety incidents is divided by the school's average daily membership (ADM) to arrive at a percentage of enrollment or School Safety Index score. A higher index score indicates a relatively higher level of reported incidents. Schools that did not report any of the serious incidents identified below will not appear in the index:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device
- Possession of a weapon other than a firearm
- Assault of a teacher or staff member
- Assault of a student
- Sexual assault
- Aggravated assault of a teacher or staff member
- Aggravated assault of a student
- Attempted homicide
- Bomb threats (new)
