SUBJECT: IAG#17-010 Addendum Individualized Family Service Plan (IFSP) Planned Service Pending

Addendum to Individualized Family Service Plan (IFSP) Planned Service Pending

- While a service is listed as *pending* on an IFSP, the service coordinator (SC) and district leadership continue to search and recruit service providers.
- When a service provider has been identified as available, the SC contacts the family, obtains a release signed by the parent for the provider, and makes a referral to the provider for the service.
- The SC notifies leadership and the data and support specialist that a provider has been located.
- Since the IFSP will be in a finalized status in TEIDS, the IFSP needs to be unlocked. The SC will complete the following in TEIDS:
 - Planned service screen: Click on service that is pending, enter ending date effective day of the change;
 - Planned service screen: Enter a new line of service and complete the new service information, adding the new service provider that has been identified for the pending service. Also enter the start date as the day of the change;
 - An IFSP requested review is not needed unless there is a change in method, setting, frequency, intensity, or payer; and
 - Contact Log: Document information in the contact log.

Both Physical Therapy (PT) and Speech Therapy (ST) were added to this IFSP in the <u>Pending</u> status (ServiceID 5 and 6). (Not shown: both pending services (ServiceID 5 and 6) had End Dates of 2/28/18 (highlighted dates were 2/28/18, now show 6/8/17), just prior to the child's 3rd birthday of 3/1/18.)

ST services were located and added to the plan (ServiceID 7). However due to the change in Payor1, a Requested Review was required.

- o An IFSP was prepopulated and a Requested Review was conducted.
- o The Pending Service for ST was ended (ServiceID 6). The new "actual" service was added for ST (ServiceID 7) with the change in Payor1 (circled).

PT services were located and added to the plan (ServiceID 8). Since no changes were required in any detail, a Requested Review was NOT required.

- o The Pending PT (ServiceID 5) was ended.
- o The "actual" PT service was added (ServiceID 8) with identical details matching those of the pending PT line (ServiceID 5).
