

# 2019-20 TCAP English Language Arts Grades 3-5 Assessment Fact Sheet

# **English Language Arts (ELA) Assessment Overview**

This fact sheet provides information about the English language arts grades 3-5 assessments. The grades 3-5 ELA assessments are administered in four subparts and assess the Tennessee Academic Standards through both literary passages and informational texts and require students to demonstrate the ability to closely read and analyze text, answer text- dependent questions, provide a written response to a prompt (two prompts in grade 3), apply knowledge and understanding of foundational literacy skills, and demonstrate command of the English language.

Students who are enrolled in a grade 3-5 ELA class must take the assessment.

English language learners are also assessed each year with an assessment called ACCESS 2.0. The results are used to determine EL placement in courses designed to support instruction for English language learners.

#### **Test Administration Information**

Testing schedules are established **by the district at the school and/or district level**. It is at the district's discretion to allow schools to set their own testing schedules, independent of a district testing schedule. # **Item Types**

The TCAP English language arts assessments are administered using both Selected Response and Constructed Response item types. These item types are used in multiple ways to elicit responses that demonstrate understanding of the Tennessee Academic Standards for ELA.

**Selected Response** items used for TCAP grades 3-5 ELA assessments can include:

- Multiple choice These are items with four answer options, only one of which is correct. Two-part multiple choice items contain a part A and a part B and may use either multiple choice or multiple select.
  - Editing task This item consists of a short passage that contains underlined text about which the student will answer questions. The student may be asked to correct an error or revise for meaning or style. For some of these editing/revision items, the underlined text will not need to be changed, and the correct answer will be "No change." In addition to editing and revision, students may also be asked to demonstrate a skill such as specificity of word choice, use of affixes, or syllabification (depending on grade level).
- Multiple select These are items with more than four answer choices with multiple correct responses.
  - This item type requires students to choose the textual evidence in Part B that supports or elaborates on the correct answer in Part A.

## **Constructed Response** items used for TCAP grades 3-5 ELA assessments include:

Written response –

**Grade 3:** Grade 3 students will experience two writing prompts on the ELA portion of the assessment. One writing passage and prompt will be literary, and one will be informational. Once the students have independently read the passage and responded to the passage based items, both the reading passage and prompt will be read out loud to the students.

Students will be asked to write **at least** one cohesive paragraph drawing

from personal experiences and evidence from the passage. The two prompts are aligned to writing standard 8. Each prompt will specify a specific mode of writing.

**Grade 4:** Students will be asked to write several cohesive paragraphs in response to a prompt. The prompt is unique to each passage or passage set. The prompt is aligned to one of three writing standards: 4.W.TTP.1, 4.W.TTP.2, or 4.W.TTP.3, and its directions explicitly indicate which mode students should respond in (e.g., opinion, explanatory, or narrative).

**Grade 5:** Students will be asked to write multiple cohesive paragraphs in response to a prompt. The prompt is unique to each passage or passage set. The prompt is aligned to one of three writing standards: 5.W.TTP.1, 5.W.TTP.2, or 5.W.TTP.3, and its directions explicitly indicate which mode students should respond in (e.g., opinion, explanatory, or narrative).
