- 3. <u>Schedule D: Science Instructional Materials Adoption</u>
  Ms. Virginia Mayfield, Senior Director, Tennessee Department of Education
  - Committee members discussed the Science Instructional Materials Adoption Schedule.
    - o Dr. Cash asked Ms. Mayfield to share information about the Science Instructional Materials adoption schedule.
    - o Ms. Mayfield shared that the commission members had a draft of the schedule to review that was created based on the final math schedule. Ms. Mayfield shared the items in the document and referenced how the timeline impacted different stakeholders involved in the process.
    - Ms. Mayfield shared the dates on the schedule and identified specific changes made as a result of the feedback provided for the math schedule. -Specifically, rubric review by the standards committee was included and the window of time for compiling advisory panelist feedback was extended. Additional time was provided for review from both the Tennessee Department of Education and the Commission.
    - Ms. Mayfield referenced that an extension to the current science contracts would be discussed during the regular meeting.
    - o Dr. Cash referenced the need for the science materials to be 100% aligned to state standards and adherence with state law.
    - Ms. Houston asked about the materials not using the Common Core Standards.
       Ms. Mayfield shared that Common Core Standards do not have science standards.
    - Ms. Mayfield shared that Mathematical Reasoning for Decision Making course was also added to the review schedule and was referenced in the Schedule D draft document.
- 4. Library Materials Guidance
  - Dr. Linda Cash, Commission Chair
  - Committee members discussed the Library Materials Guidance document.
    - Dr. Cash referenced the library guidance document that had been reviewed by the Attorney General's office to ensure the document meets state law requirements and aligns with the intentions in the law.
    - Dr. Cash shared one recommendation of adding the word 'are', as a clarifying word for consistency in the document, on the first page, in the last sentence under section B.
    - o Dr. Cash also discussed the suggestion to align the language between LEA and the State Board of Education and shared that the changes would not be necessary.
    - Dr. Cash reminded the committee that the guidance document was legally reviewed and thanked the Attorney General's office for its support.
