The proposed construction and/or modification is subject to part 1200-03-09-.01(1)(h) of the Tennessee Air Pollution Control Regulations, which requires a public notification and 30-day public comment period. Construction permits issued by TDAPC do not grant any authority operate, construct, or maintain any installation in violation of any law, statute, code, ordinance, rule, or regulation of the State of Tennessee or any of its political subdivisions.
