**INSTRUCTIONS TO APPLY FOR  
A VEHICLE EMISSIONS EXEMPTION  
FOR VEHICLES REGISTERED IN  
HAMILTON, RUTHERFORD, SUMNER, WILLIAMSON OR WILSON COUNTY**

These instructions pertain only to vehicles registered in Hamilton, Rutherford, Sumner, Williamson and Wilson Counties. If a vehicle is out of the state or testing area and tags are due for renewal, your vehicle may be eligible for a vehicle emissions exemption. In such circumstances, the State offers an exemption from the vehicle emissions testing requirement for as long as the vehicle is out of the area. If your vehicle is out of the area for more than one year, you must reapply each year to receive an exemption.

If you are a resident of Davidson County, call (615) 340-5656 for exemption information.

You must complete the Application for Vehicle Exemption Form in order to apply for and receive a vehicle exemption from the emissions testing requirements of Chapter 1200-3-29. You must provide a physical address showing your residence in Hamilton, Rutherford, Sumner, Williamson, or Wilson County and provide a telephone number where you can be reached. Follow the steps below:

1. TO APPLY YOU **MUST** SUBMIT THE FOLLOWING:

- Completed application form
- **Must include** a copy of your vehicle's registration or documents of purchase and
- Documentation showing the vehicle is out of the State or testing area (**For example:** Current School Tuition Receipt, Utility Bill, or Military LES) to the Division of Air Pollution Control for processing. **An exemption cannot be granted with out the appropriate documentation.**

This will delay processing and approval.***

2. Upon receipt, the Division will review application for completeness. If the vehicle qualifies, the division will issue a Certificate of Compliance exemption and you will be notified by phone or email when the exemption has been submitted electronically to the appropriate County Clerk's office. Once the Clerks' office receives this information, you can complete your registration renewal at your convenience.
3. When the vehicle returns to the emissions testing area, it must be tested and pass an emissions test. For station testing locations and operating hours – access <https://www.tn.gov/environment/program-areas/apc-air-pollution-control-home/vehicle-inspection-program.html>
