Discussion of CAP membership change

- Proposal for at-large members of the CAP. This can increase the CAP size above the minimum seven per the Clean Air Act Section 507 rule.

Michael explained that there is no problem with adding an at-large member. There would be no meaningful difference in whether a member is at-large. Section 507 provides the minimum requirement of 7 members, but does allow more.

Kerry motioned to accept Clay as at-large member. Lacey seconded. Motion passed.

General Permit for Concrete Ready-Mix

- Public Hearing scheduled for May. 13, 10 am Central time on first floor of Davy Crockett building (address in link)
 - Concrete Plants – (Uncontrolled Loadout): The annual production rate shall not exceed 450,000 cubic yards per calendar year of ready-mixed concrete.
 - Concrete Batch Plants – (Controlled Loadout): The annual production rate shall not exceed 2,600,000 cubic yards per calendar year of ready-mixed concrete.
 - Should cover both truck and central mix plants. Emissions limit of 79.9 tons/year due to enhanced EPA scrutiny and reporting requirements of sources with more emissions.

Alan said: Annual production in TN in 2024 is under 9 million yards total; therefore, it should cover all activities not already covered by small batch (i.e., all ready-mix activities will be covered by a GP). Most concrete plants are controlled.

SBEAP Database upgrades

- Ideas for items on dashboard?
 - Can map be interactive
 - Can interactive include ability to compare assistance over time? Can help look at trends
- New database may also help SBEAP determine impacts such as fees avoided.
