The Division issued **28** orders between January 21, 2021 and May 13, 2021.

Of those orders, 3 are in Appealed status and 6 are in Final-Probation status.



Appealed Orders



Appealed Order – In OGC

Summary of UST20-0133

Fac. ID No. 8-200092 / Ski Daddy's LLC

- Director's Order signed February 1, 2021
- Order appealed on March 11, 2021
- Order for:
 - Failing to install the solenoid required to correct for the slope from piping to tank top of the diesel UST
 - Failing to monitor the tanks and piping for a release at least every 30 days
 - Failing to provide documents, testing and monitoring records
- Civil Penalty \$21,120.00
- The case has been appealed and is in OGC



Appealed Order – In OGC

Summary of UST20-0138

Fac. ID No. 8-490140 / Midway Grocery No. 3

- Director's Order signed March 24, 2021
- Order appealed on April 23, 2021
- Order for:
 - Failing to have one or more petroleum UST systems to have one or more persons designated as Class A, Class B and Class C Operators
 - Failing to provide documents, testing and monitoring records
- Civil Penalty \$4,560.00
- The case has been appealed and is in OGC



Appealed Order – In OGC

Summary of UST20-0141

Fac. ID No. 2-870012 / Friends Market and Deli

- Director's Order signed February 5, 2021
- Order appealed on March 22, 2021
- Order for:
 - Failing to provide release detection method capable of detecting a release from tank that routinely contains product
 - Failing to designate Class A, Class B and Class C operators
 - Failing to maintain records of impressed current cathodic protection rectifier inspections
 - Failing to ensure that cathodic protection system is tested within 6 months of installation and every 3 years thereafter
 - Failing to operate and maintain corrosion protection system to provide continuous protection
 - Failing to provide documents, testing and monitoring records
- Civil Penalty \$32,800.00
- The case has been appealed and is in OGC
