#### **BACKGROUND**

On August 8, 2017, the BOE issued a Policy for Developing Policy and Guidance. The BOE has templates for Policy and Guidance documents.



## **BACKGROUND** (continued)

"Guidance" means a non-binding agency statement that explains the objective of rules or regulatory requirements and provides advice on compliance with the rule. These include: Compliance Guides, Regulatory Interpretive Memorandum, etc.



## **BACKGROUND** (continued)

"Policy" means a set of decisions, procedures and practices pertaining to the internal operation or actions of an agency. These include: Standard Operating Procedures (SOPs), Good Practice Guidelines (GxP), Checklists, Memoranda of Understanding or Memoranda of Agreement between Divisions, etc.

# **Updated Special Waste Guidance (SWG)**

# **Updated Draft SWG**

The draft SWG has been updated to be consistent with BOE Policy and to make the document more user friendly. Items 11 through 18 have been added on page 4 to include K listed hazardous waste. There have been several clarifications made including evaluation outcomes, use of safety data sheets, and TCLP Analyses. Sections D and G have been added to include information on Prohibited or Restricted Wastes and Laboratory Reports, respectively. The draft updated SWG has been reviewed by an attorney with the TDEC Office of General Counsel.



# **Policy**

The draft Standard Operating Procedure (SOP) – Processing Closure Certifications/Documents provides the procedures for DSWM employees to assist in the processing of Closure Certifications/Documents to verify that a closure has been completed in accordance with the most recent approved closure plan and the final cover system was constructed in accordance with the most recent approved construction quality assurance plan.

This SOP directs DSWM Staff and provides no guidance. The draft SOP has been reviewed by an attorney with the TDEC Office of General Counsel



#### **Path Forward**

Barring any unexpected issues, the DSWM intends on finalizing the Updated Special Waste Guidance, emailing the updated guidance and our response to comments to those who commented on the draft, and posting it on the BOE and DSWM web pages.
