Division Committee

Six Division staff, consisting of two co-chairs, two reimbursement staff, and two contamination project managers.

Conducted research via websites and direct contact.

Then proposed revisions based on information obtained.



Division Review

Senior project managers reviewed, provided comments / recommendations, and then committee revised to address.

Final step by staff was an impact analysis of the proposed revisions, compared to reimbursement applications submitted from July 2019 through June 2021.

To address a large portion of the miscellaneous charges, tasks for the following are proposed to be included in RGD-002

- Advanced Site Characterization (3.9 series)
- Injection (4.4.e series)



Impact of Proposed Changes

Category	Impact
Personnel	3.1% Increase
Reports	1.1% Increase
Well Installation and Abandonment	1.1% Increase
Supplies and Rentals	0.5% Decrease
Analysis	0.2% Decrease
Sampling and Well Survey	0.5% Increase
Mileage	0.6% Increase
Excavation, Hauling, and Disposal*	0.3% Increase
Trench (CAS Installation)	0.3% Increase
Manifold	0.1% Increase



Personnel

- US Bureau of Labor Statistics for TN.
- Personnel rates reimbursed by nearby state UST programs.
- Outreach with regulated community.

Compared all to determine a reasonable rate



Reports/Applications/Proposal

Adjusted for personnel rate changes.

Re-evaluated time estimated for each.





Limited changes to this category.

Costs varied drastically from laboratory to laboratory.



Well Install and Abandonment (drilling)

No longer reimburse for individual drums.

Costs included with drum disposal.



Rentals and Supplies

Typical equipment that is routinely utilized will no longer be reimbursed at daily rental rates.



Groundwater Sampling and Survey

Routine equipment taken into consideration for lump sum tasks.



Mileage (Mob/Demob)

Mob/demob of excavation equipment and drill rigs:

Minimum charge (within 100 miles round trip) and per mile rate increase.

Roundtrip distance:

Increase from 250 miles to 300 miles.



Hauling and Disposal (not all comparable)

Hauling changed from a flat rate based on mileage to per hour (dump truck hourly rate and truck driver hourly rate)

Drum disposal increased from \$90 to \$200 (includes cost of drum and transport)



Trench (Recovery and Discharge)

RW trench still on a per foot basis

1 to 5 lines at \$82

6 - 10 lines at \$94
