Active Full Permit Applications Class I - 8Class II – 5 Class III/IV – 11 Tier II/III Compost - 1



- Carter Valley Class I Vertical Expansion (Hawkins Co)
 - Awaiting complete responses to a Notice of Deficiency (NOD) issued in 2022
- White County Class I Lateral Expansion
 - Complete Part IIA received, TDEC actively working with County on pathway forward.
- Rhea County Class I Lateral Expansion
 - NOD issued on 3/22/20



- Bi-County Class I Lateral Expansion (Montgomery Co)
 - Part I submitted Nov 2020.
- Middle Point Class I (Rutherford Co)
 - All review suspended pending local approval.
- Hamblen County Class I Lateral Expansion
 - Have received an incomplete Part IIA hydrogeologic report in 2022.



- Smith County Class I Lateral Expansion
 - Part I submitted October 2022
 - Very small lateral expansion to continue operations as facility has limited capacity remaining.



- TVA Cumberland CCR Class II (Stewart Co)
 - Part IIB received and reviewed. A NOD has been issued.
- Eastman Class II Chemical Ground Water and Narrative Major Mod (Sullivan Co)
 - Awaiting NOD response
 - The requested changes consist of changes to the Variances and Waivers section of the permit triggering a major modification
 - Does not add capacity



- PCA Class II Landfill (Hardin Co)
 - Awaiting Part II permit application
 - Part I noticed published on 11/24/2022



- Sevier County Class III Lateral Expansion
 - Complete Part IIB received
- City of Milan Class III Vertical and Lateral Expansion
 - Engineering Report Under Review.
- Alcoa/Blount Class III Lateral Expansion
 - Awaiting Part IIB Engineering to be submitted.
 - Two part lateral expansion will be issued as two permit modifications if approved.



- Bi-County Woodlawn Class III Vertical Expansion
 - Reviewing corrections to engineering Part IIB.
- Bi-County St. Bethlehem Class III Vertical Expansion
 - Public Comment period ends 4/17/2023



- Perry County Class III Vertical/Lateral Expansion
 - Engineering and Part IIB under review
- Jefferson County Class III Vertical/Lateral Expansion
 - Hydrogeologic report deemed incomplete
- Hickman County Class III Vertical/Lateral Expansion
 - Engineering and Part IIB under review



- Riverside Class III Vertical/Lateral Expansion (Knox Co)
 - Waiting on Part IIA
- North Memphis Class III Vertical Expansion (Shelby Co)
 - Part IIB Received 3/20/2023
