Updated Draft of the Disposal of Petroleum Contaminated Soil and Debris in Class I Landfills - Guidance

The Draft Disposal of Petroleum Contaminated Soil and Debris in Class I Landfills – Guidance has been updated to: 1) Be consistent with BOE Policy; 2) Reference new and updated guidance documents; 3) Provide suggested number of soil samples; and 4) Clarify that petroleumcontaminated media and debris that fail the test for the Toxicity Characteristic of Rule 0400-12-01-.02(3)(e) (Hazardous Waste Codes D018 through D043 only) and are subject to the corrective action regulations under 40 CFR Part 280 or Chapter 0400-18-01 are not hazardous waste.

This draft has been reviewed by an attorney with the TDEC Office of General Counsel and any comments incorporated.



Barring any unexpected issues, since the changes are minor, the DSWM intends on issuing the updated guidance after this Board meeting.

New Draft Standard Operating Procedure (SOP) for Special Waste Evaluations - Policy

The new draft Standard Operating Procedure (SOP) for Special Waste Evaluations - Policy provides the procedures for DSWM employees to assist in the processing, reviewing, documenting, and evaluating special waste applications/recertifications for waste disposal in a Class I II, III, or IV Tennessee permitted disposal facility and processing at a Tennessee permitted solid waste processing facility.

The draft has been reviewed by an attorney with the TDEC Office of General Counsel.
