

Division of Solid Waste Enforcement Update

Underground Storage Tanks and Solid Waste Disposal Control Board October 4, 2023

ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued one Hazardous Waste Order and one Solid Waste Order between July 14 and September 20, 2023.
- Two orders require an update from the previous Board meeting.

Director's Order - Signed

Summary of Solid Waste Order SWM23-0001

Fac. ID No. NRS820000626/1120 Pleasant Grove Road, Sullivan County.

- Signed May 11, 2023.
- Order issued for T.C.A. violations including:
 - Unauthorized burning of solid waste
 - Unauthorized operation of a solid waste processing
 - Unauthorized transportation and disposal of solid waste
- Upfront Civil Penalty \$5,000.00
- Damages \$758.52
- Due to unclear address and property ownership, the order was individually served on September 11, 2023.
- Order is within 30 day timeframe.



Commissioner's Order - Signed

Summary of Hazardous Waste Order HWM23-0003

Fac. ID No. TNR000024018/Mega-Mind, dba Atlantic Coast Plating, McMinn County.

- Signed September 6, 2023.
- Order issued for rule violations including:
 - Failure to conduct hazardous waste determinations
 - Failure to notify the Division of the generation of hazardous waste
 - Failure to have tank system certifications
 - Failure to determine generator category
 - Failure to conduct to weekly inspections
 - Failure to have emergency response equipment
- Upfront Civil Penalty \$205,400.00
- Damages \$1,237.50
- Order is within 30 day timeframe



HW Director's Order – Closed

Summary of Hazardous Waste Order HWM23-0003

Fac. ID No. TN000031070/Onyx Medical Corp. dba Elos MedTech Memphis, Shelby County

- Signed July 11, 2023.
- Order issued for rule violations including:
 - Container labelling
 - Deficient and missing weekly inspections
 - Universal waste handling
 - Failure to update Hazardous Waste Reduction Plan
- Upfront Civil Penalty \$3,760.00
- Damages \$487.50
- Civil Penalty and Damages paid July 28, 2023. Case is Closed.



HW Director's Consent Order - Closed

Summary of Hazardous Waste Order HWM22-0007

Fac. ID No. TN000590612/Phoenix Redevelopment Bristol LLC, Sullivan County

- Signed February 6, 2023.
- Order issued for rule violations including:
 - Failure to conduct HW determinations
 - Unlawful disposal of HW
 - Container labeling and management
- Upfront Civil Penalty \$6,500.00 was paid June 20, 2023.
- Damages \$6,688.52 were paid June 20,2023.
- Contingent Civil Penalty \$10,000.00 pending the complete removal of remaining HW from facility.
- Contingent Civil Penalty \$10,000.00 pending submittal of manifests documenting the shipment and disposal of HW from facility.
- Shipping documents received in emails submitted between August 28 and September 7, 2023. Case is Closed.
