Permitting Update

Current Permits Under Review: Class I

- White County Class I Lateral Expansion
 - We have a complete Part II (A&B application) as of 11/6/2024
 - Part A : Hydrogeological Investigation Report
 - Part B : Operations Manual, Engineering, Closure/Post-Closure Care Plan, Groundwater Monitoring Plan.
 - Field office and Central Office have started the technically review process

Permitting Update

Current Permits Under Review: Class I

- Bi-County Class I Lateral Expansion (Montgomery Co)
 - Hydrogeological and site investigations are currently underway by the applicant's consultants in preparations for the submittal of a Part II permit application. We expect to have an informal discussion with them prior to submittal in December or January
- Hamblen County Class I Lateral Expansion
 - Central office and field office collaborated on technical review of the Part II application on 11/26/2024 including a site visit.

Permitting Update

Current Permits Under Review: Class I

- Smith County Class I Lateral Expansion
 - Part II application deemed to be complete on 10/22/2024
 - Central office and field office have been meeting online and on site to review the technical aspects of the submittal.
- Jefferson County Vertical Expansion
 - Revises contours, ponds and closure
 - Notice of Deficiency on Part II issued on 6/9/2024 with a response on 10/17/2024.
 - Joint central office and field office meeting scheduled on 12/19/2024 to discuss resubmittal.

Permitting Update

Current Permits Under Review: Class I

- Loudon County Landfill Lateral Expansion
 - Public hearing was held on 11/12/2024.
 - Public comment period ends on 12/23/2024
- Marion County Landfill Lateral Expansion
 - Ongoing since June of 2023 to correct historic overfill situation
 - A notice of deficiency for the Part II application was issued 7/2/2024
 - Awaiting a response.

Permitting Update

Current Active Permits Under Review: Class II

- Gateway View Landfill (Post Closure Foundry Sand, Hamilton County)
 - Termination of DSWM permit
 - Transfer of oversight to Division of Remediation Brownfield Voluntary Cleanup Oversight and Assistance Program
 - Public Notice issued 12/1/2024
 - Public Hearing scheduled 12/16/2024
 - Public Comments end 1/15/2024

Permitting Update

Current Permits Under Review: Class III

- City of Milan Class III Vertical and Lateral Expansion
 - Part II application was received on 10/31/2023 for additional airspace. This is paused at the request of applicant pending potential new Part I.
- Alcoa/Blount Class III Lateral Expansion
 - Part IIB Engineering for South Cell does not meet siting criteria, working with applicant on possible resolutions and additional comments.
 - May need a modification to Class I to proceed. Had meeting on 10/29/2024 to discuss with applicant.

Permitting Update

Current Permits Under Review: Class III

- Perry County Class III Vertical/Lateral Expansion
 - Notice of deficiency issued on Part II in 8/7/2023 for failure to provide adequate groundwater monitoring network.
 - New well installed on 9/4/2024.
 - Awaiting additional information on that well.
- Jefferson County Class III Vertical/Lateral Expansion
 - Engineering Deemed Complete on 7/23/24
 - Part II notice of deficiency issued on 11/8/2024

Permitting Update

Current Permits Under Review: Class III

- Riverside Class III Vertical/Lateral Expansion (Knox Co)
 - Received Complete Part II application 10/14/2024
 - Central office and field office peer review meeting scheduled 12/5/2024
- Claiborne County Class III New Landfill
 - Part IIA Hydrogeologic Report deemed incomplete on 11/4/2024
 - Held meeting with applicant on 11/7/2024 to discuss incomplete permit submittal.

Permitting Update

Current Permits Under Review: Class III

- Poplar View Landfill (Knox Co) Vertical Expansion
 - Complete Part II application received 9/13/2024
 - Central office and field Office Peer Review meeting held 11/4/2024 with notice of deficiency issued.
- Bi-County St. Bethlehem Class III (Change in Post Closure Period)
 - Public comment period ends 12/13/2024

Permitting Update

Current Permits Under Review: Class III

- Birchwood Class III Landfill (Hamilton County)
 - Transfer of ownership to Capital Waste Services received 11/20/2024
