

Hazardous Waste Permitting 2nd Quarter FY24 Update

Presented to the Underground Storage Tanks and Solid Waste Disposal Control Board

Introduction

Tennessee statute requires a quarterly update on the **timeliness** of permit processing by the Division of Solid Waste Management (DSWM) to be provided to the Board. This report is for the State's Second Quarter FY24 October 1, 2023 – December 31, 2023.

Tennessee regulations specify **time limits** for applications:

- Completeness reviews/determinations
- Approval or denial (Class 2 modifications and new commercial applications)
- For the following:
 - Part B permit applications
 - Class 1 and ¹1 permit modifications
 - Class 2 permit modifications
 - Class 3 permit modifications
- TDEC issues Notice of Deficiencies/Comments if submittal is incomplete


