ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued two Hazardous Waste Orders and no Solid Waste Orders between May 15, 2024, and September 23, 2024.
- From previous Board meetings, two orders require an update.

Orders Issued – Closed

- Fac. ID No. TNR000047696/EM Printing, Shelby County.
 - HWM24-0004 Directors Order
 - Signed June 27, 2024.
 - HW determinations, container labeling and handling, employee training, weekly inspections, arrangements with local authorities and annual reporting.
 - Civil Penalty \$9,800.00 and Damages \$1,728.00 were paid July 25, 2024.
 - Case is Closed.

- Fac. ID No. TND980603054/Explore Industries, Knox County
 - HWM24-0007 Directors Order
 - Signed July 9, 2024.
 - HW determination documentation, weekly inspections employee training, reporting and record-keeping, emergency preparedness information.
 - Civil Penalty \$9,520.00 and Damages \$1,064.00.
 - Order delivered to registered agent August 2, 2024.
 - Civil Penalty and Damages paid September 25, 2024.
 - Case is Closed.

Orders Issued – Update

- Fac. ID No. NRS370000403/Goins Property – Goins Trust, Hawkins County.
 - SWM23-0003 Directors Order
 - Signed February 14, 2024.
 - Unlawful Disposal.
 - Civil Penalty \$6,400.00 and Damages \$1,987.00.
 - Unable to locate Respondent. Property ownership is uncertain.
 - Order served August 15, 2024, via third party service.
 - Order was Final on September 16, 2024.
 - Civil Penalty and Damages referred to Fiscal Services.
- Fac. ID No. TND000772186/Tradebe TSDF, Shelby County.
 - HWM23-0008 Commissioners Order
 - Issued October 19, 2023.
 - Appealed November 15, 2023.
 - Settlement Agreement signed August 22, 2024.
 - Repeat Permit Violations – storage for more than one year, improper container handling and aisle space.
 - Civil Penalty \$153,075.00 and Damages \$2,025.00.
 - Civil Penalty and Damages paid September 12, 2024.
 - Anticipating final compliance documentation by October 31, 2024.
