ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued five Hazardous Waste Orders and one Solid Waste Order between November 20, 2024, and January 17, 2025.
- From previous Board meetings, two orders require updates.



Orders Issued – Signed

- Fac. ID No. TND981023674/Cymer Dayton, Rhea County.
 - HWM24-0022 Directors Order
 - Signed December 16, 2024.
 - HW determinations container labeling and handling, tank integrity testing, tank and equipment labeling and leak testing, record keeping and training.
 - Civil Penalty \$13,570.00 and Damages \$2,105.70.
 - Order delivered December 26, 2024. Within 30-day response window.
- Fac. ID No. TXR000081205/Safety-Kleen Systems, Inc. Shelby County
 - HWM24-0018 Commissioners Order
 - Signed January 9, 2025.
 - Transfer Facility violations including failure to maintain a log of all hazardous waste shipments, failure to include generator facility identification number in shipment logs, operating a storage facility without a permit.
 - Civil Penalty \$101,600.00 and Damages \$1,200.00.
 - Within 30-day response window.



Orders Issued – Signed

 - HWM24-0015 Directors Order
 - Signed January 17, 2025.
 - HW container labeling and handling, weekly inspections, annual reporting, out of date facility contact information, no documentation of local emergency response arrangements.
 - Civil Penalty \$3,220.00 and Damages \$1,500.00.
 - Within 30-day response window.

 - Signed December 6, 2024.
 - HW determinations and record-keeping, container labeling, annual reporting and arrangements with local authorities.

 - Payment received December 24, 2024.
 - Case is Closed.

 - SWM24-0018 Directors Order
 - Signed November 26, 2024. Delivered November 29, 2024.
 - Unlawful used tire disposal. Respondent has submitted documentation of partial removal.
 - Civil Penalty \$6,600.00 contingent on removal of waste within 90 days.
 - Damages \$612.96 due on or before 31st day after receipt. Referred to Fiscal Services.

 - HWM24-0014 Directors Order
 - Signed November 15, 2024.
 - Missing daily and weekly inspection records, failure to maintain LDAR records, failure to file exception reports, failure to sign manifests of rejected loads.
 - Civil Penalty \$36,600.00 and Damages \$1,800.00.
 - Payment received December 27, 2024. Case is Closed.
