# Permitting Update

## Current Permits Under Review: Class I

- White County Class I Lateral Expansion
  - We have a complete Part II (A&B application) as of 11/6/2024
    - Part A : Hydrogeological Investigation Report
    - Part B : Operations Manual, Engineering, Closure/Post-Closure Care Plan, Groundwater Monitoring Plan.
  - Notice of Deficiency (NOD) issued 1/17/2025
  - Response Received on 2/11/2025
  - Notice of Deficiency (NOD) issued 3/14/2025

# Permitting Update

## Current Permits Under Review: Class I

- Bi-County Class I Lateral Expansion (Montgomery Co)
  - Hydrogeologic Report submitted 4/10/2025
  - Part I Preliminary Notice published 4/17/2025
- Hamblen County Class I Lateral Expansion
  - In person meeting held with applicants and consultants on 4/21 to correct errors in the submittal.

# Permitting Update

## Current Permits Under Review: Class I

- Smith County Class I Lateral Expansion
  - Meeting with applicants 4/10/2024
  - Final NOD issued 4/24/2024
- Jefferson County Vertical Expansion
  - Revises contours, ponds and closure
  - Second NOD on Part II issued on 1/2/2025
  - Still no response.

# Permitting Update

## Current Permits Under Review: Class I

- City of Milan Class I (never constructed, never operated)
  - Request to terminate permit received 2/10/2025
  - Notice published 4/1/2025
  - End of public comment period 5/16/2025
- City of Dyersburg Class I Vertical Expansion
  - Part II received 3/31/2025- under review

# Permitting Update

## Current Active Permits Under Review: Class II

- Gateway View Landfill (Post Closure Foundry Sand, Hamilton County)
  - Termination of DSWM permit
  - Transfer of oversight to Division of Remediation Brownfield Voluntary Cleanup Oversight and Assistance Program
  - Public Notice issued 12/1/2024
  - Public Hearing scheduled 12/16/2024
  - Public Comments ended 1/15/2024
  - Coordinating termination date with DoR timetable.

# Permitting Update

## Current Permits Under Review: Class III

- City of Milan Class III Vertical and Lateral Expansion (now Caraway Hills Landfill)
  - Part II application was received on 10/31/2023 for additional airspace. This is paused at the request of applicant pending new Part I and change of ownership
  - Change of ownership completed 4/11/2025
  - Revised Part I received 4/15/2025
- Alcoa/Blount Class III Lateral Expansion
  - No longer compatible with Class I Phase 6 overlay, resubmittal will be needed if pursued.

# Permitting Update

## Current Permits Under Review: Class III

- Perry County Class III Vertical/Lateral Expansion
  - Notice of deficiency issued on Part II in 8/7/2023 for failure to provide adequate groundwater monitoring network.
  - New well installed on 9/4/2024.
  - Awaiting additional information on that well.
- Jefferson County Class III Vertical/Lateral Expansion
  - Engineering Deemed Complete on 7/23/24
  - Part II NOD issued on 11/8/2024
  - Incomplete response to NOD received on 1/22/2024



# Permitting Update

## Current Permits Under Review: Class III

- Riverside Class III Vertical/Lateral Expansion (Knox Co)
  - NOD issued on 12/16/2024
  - Meeting held with applicant and consultants to address NOD 2/27/2025
- Claiborne County Class III New Landfill
  - Part IIA Hydrogeologic Report deemed incomplete on 11/4/2024
  - Held meeting with applicant on 11/7/2024 to discuss incomplete permit submittal.
  - Additional groundwater monitoring wells need to be established prior.

# Permitting Update

## Current Permits Under Review: Class III

- Poplar View Landfill (Knox Co) Vertical Expansion
  - Central office and field Office Peer Review meeting held 11/4/2024 with notice of deficiency issued.
  - Response to NOD issued 3/11/2025
  - Final permit review with leadership schedule 5/9/2025

# Permitting Update

## Current Permits Under Review: Class III

- Birchwood Class III Landfill Lateral Expansion
  - Part I received 2/14/2025
  - Preliminary notice published 3/23/2025
- Lawrenceburg Class III Landfill revised waste limits for closure
  - Draft Part II submitted and under courtesy review for feasibility input from DSWM 4/25/2025.

# Permitting Update

## Current Permits Under Review: Class III

- McMinn County Class III Landfill Lateral Expansion
  - Preliminary notice published 4/12/2025
  - Hydrogeologic report deemed complete on 4/25/2025
