

Division of Solid Waste Enforcement Update

Underground Storage Tanks and Solid Waste Disposal Control Board May 7, 2025

ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued two Hazardous Waste Orders and no Solid Waste Orders between January 17, 2025, and April 11, 2025.
- From previous Board meetings, five orders require updates.



Orders Issued – Signed

- Fac. ID No. TND083275198/SRG Global Coatings Lauderdale County
 - HWM24-0024 Directors Order
 - Signed February 7, 2025, and delivered February 12, 2025.
 - Employee training, weekly inspections, failure to notify on waste stream generation, annual report deficiencies and universal waste labeling.
 - Civil Penalty \$8,700.00 and Damages \$1,350.00.
 - Order Final March 14, 2025. Civil Penalty and Damages referred to Fiscal Services.
- Fac. ID No. TND007020209/Toof Commercial Printing, Shelby County.
 - HWM24-0026 Directors Order
 - Signed April 2, 2025.
 - HW container labeling, weekly inspections, no documentation of local emergency response arrangements, no contingency plan, no waste reduction plan.
 - Civil Penalty \$4,500.00 and Damages \$2,100.00.
 - Within 30-day response window.



Orders Issued – Update

- Fac. ID No. TND981023674/Cymer Dayton, Rhea County.
 - HWM24-0022 Directors Order
 - Signed December 16, 2024.
 - HW determinations container labeling and handling, tank integrity testing, tank and equipment labeling and leak testing, record keeping and training.
 - No Appeal received. Order Final on January 20, 2025.
 - Civil Penalty \$13,570.00 and Damages \$2,105.70 referred to Fiscal Services.
- Fac. ID No. TXR000081205/Safety-Kleen Systems, Inc. Shelby County
 - HWM24-0018 Commissioners Order
 - Signed January 9, 2025.
 - Transfer Facility violations including failure to maintain a log of all hazardous waste shipments, failure to include generator facility identification number in shipment logs, operating a storage facility without a permit.
 - Civil Penalty \$101,600.00 and Damages \$1,200.00.
 - Appealed March 27, 2025.

 - HWM24-0015 Directors Order
 - Signed January 17, 2025.
 - HW container labeling and handling, weekly inspections, annual reporting, out of date facility contact information, no documentation of local emergency response arrangements.
 - Civil Penalty \$3,220.00 and Damages \$1,500.00 paid March 5, 2025.
 - Case is Closed.
- Fac. ID No. TNR000031054/Mitsubishi Chemical America, Shelby County.
 - HWM24-0017 Directors Order
 - Signed November 21, 2024.
 - HW container labeling and handling, tank and accumulation area inspections, annual reporting and contingency plan.
 - Civil Penalty \$4,550.00 and Damages \$2,662.50 paid January 31, 2025.
 - Case is Closed.



Orders Issued – Update

- Fac. ID No. NRS100000475/106 Marion Branch Road, Carter County.
 - SWM24-0018 Directors Order
 - Signed November 26, 2024. Delivered November 29, 2024.
 - Unlawful used tire disposal. Respondent has submitted documentation of partial removal.
 - Civil Penalty \$6,600.00 contingent on removal of waste within 90 days.
 - Damages \$612.96 due on or before 31st day after receipt. Referred to Fiscal Services.
 - Local authorities are working with property owner to clean up the parcel.
