ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued five Hazardous Waste Orders and two Solid Waste Orders between April 11, 2025, and July 29, 2025.
- From the previous Board meeting, updated payment information is unavailable for Director's Orders HWM24-0024 and HWM24-0022 due to ongoing upgrades to the interface between WasteBin and Fiscal Services. From the previous Board meeting, one order can be updated.

Orders Issued – Update

- Fac. ID No. TND007020209/Toof Commercial Printing, Shelby County
 - HWM24-0026 Director's Order
 - Signed April 2, 2025.
 - HW container labeling, weekly inspections, no documentation of local emergency response arrangements, no contingency plan, no waste reduction plan
 - Civil Penalty \$4,500.00 and Damages \$2,100.00 paid May 30, 2025
 - Case is Closed

Orders Issued – Signed

 - HWM24-0028 Director's Order
 - Signed April 2, 2025
 - Container labeling and dating, storage over 90 days, no spill kits in satellite accumulation areas, missing weekly inspections and universal waste labelling and storage greater than one year
 - Civil Penalty \$7,900.00 and Damages \$1,725.00
 - All violations returned to compliance. Payment received May 22, 2025

 - Damages \$1,725.00
 - Within 30-day appeal period
