# Introduction

Tennessee statute requires a quarterly update on the **timeliness** of permit processing by the Division of Solid Waste Management (DSWM) to be provided to the Board. This report is for the State's Fourth Quarter FY25 April 1, 2025 – June 30, 2025.

Tennessee regulations specify **time limits** for applications:

- Completeness reviews/determinations
- Approval or denial (Class 2 modifications and new commercial applications)
- For the following:
  - Part B permit applications
  - Class 1 and <sup>1</sup>1 permit modifications
  - Class 2 permit modifications
  - Class 3 permit modifications
- TDEC issues Notice of Deficiencies/Comments if submittal is incomplete

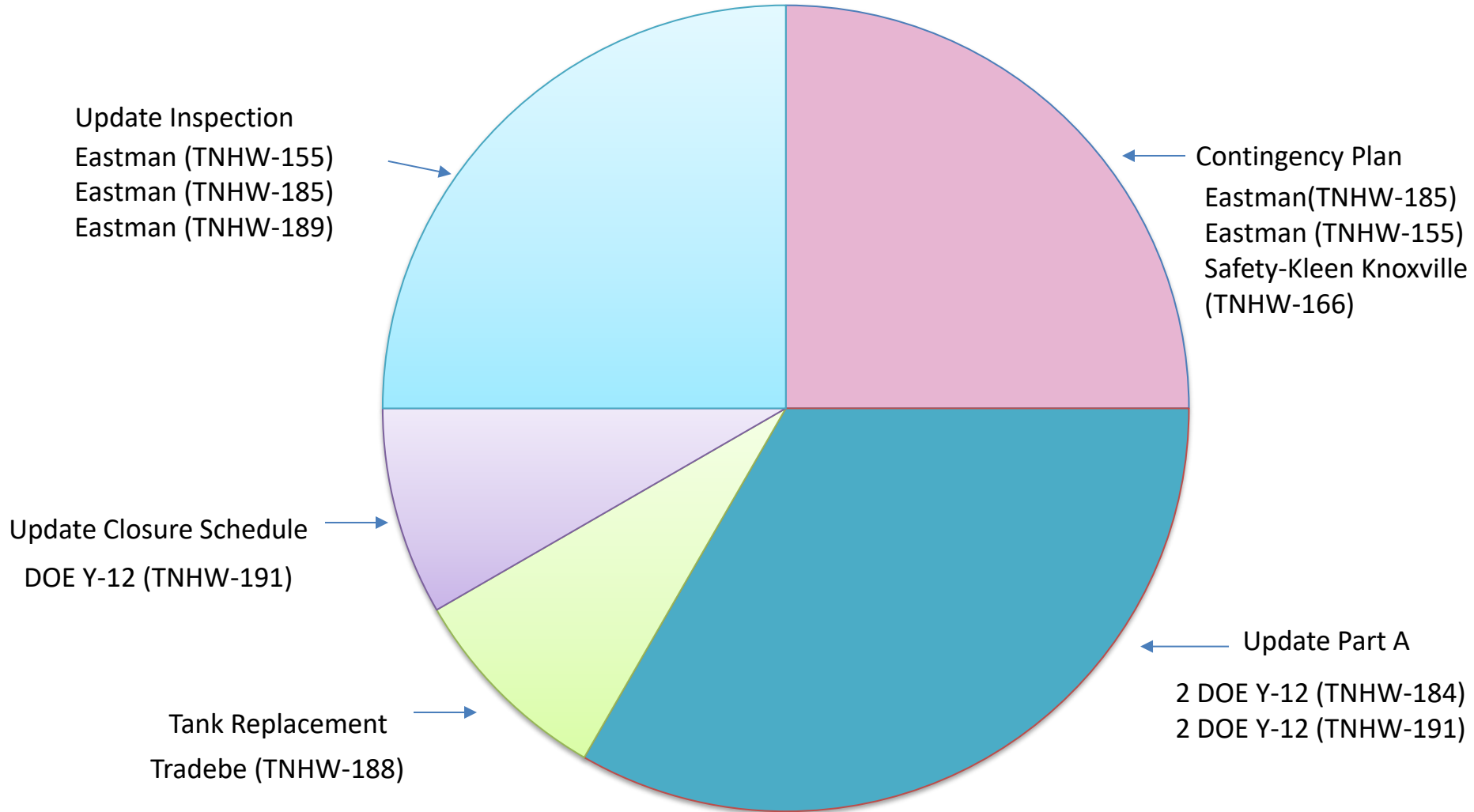
