

Underground Storage Tank Enforcement Update

Underground Storage Tanks and Solid Waste Disposal Control Board August 13, 2025

ENFORCEMENT OVERVIEW

The Division issued 43 orders between April 1, 2025, and June 30, 2025.

- 23 are Fund Orders of those Fund Orders.
 - 3 are in Final status.
 - 1 in Final-Probation.
 - 1 in Final-Remediation.
 - 3 were Appealed
 - 3 were closed.
 - 6 are in Signed Status.
 - 6 are in Signed-Pending SOP status.

- 20 are Compliance orders of those orders.
 - 1 is in Final status.
 - 4 were Appealed.
 - 5 are in Signed Status.
 - 10 in Signed-Pending SOP status.



Enforcement Overview (cont'd)

From March 1, 2025, to June 30, 2025:

The Division assessed \$250,485 in civil penalties.

Fac. ID No. 5-190078/ Ben Little's, Inc., Nashville, Davidson County

- Fund Deductible Amount Order signed April 9, 2025.
- Violations in Order:
 - Failure to conduct a site check.
 - Failure to conduct a system test when there is a suspected release.
 - Failure to report a confirmed release to the Division within seventy-two (72) hours.
 - The Application for Fund Eligibility is approved with a deductible of \$20,000.
 - The order became final June 20, 2025. The Division is currently working with the Respondent to come into compliance.

Fac. ID No. 1-820109/ Cupboard Food Market, Johnson City, Sullivan County

- Fund Deductible Amount Order signed April 23, 2025.
- Violations in Order:
 - Failure of facility having one or more petroleum UST systems to have one or more persons designated as Class A, Class B and Class C Operators.
 - Failure to conduct annual line tightness test or do monthly monitoring on pressurized underground piping.
 - Failure to conduct a system test when there is a suspected release.
 - Failure to report a change of status for a UST system within 30 days.
- The Application for Fund Eligibility is approved with a deductible of \$20,000.
- The order became final June 5, 2025. The facility is red-tagged and is currently in OGC.

- Fund Eligibility Denial Order signed April 24, 2025.
- Violations in Order:
 - Failure to install, calibrate, operate, or maintain release detection method for tank in accordance with manufacturer's instructions.
 - Failure to report a suspected release to the Division within seventy-two (72) hours.
 - Failure to monitor tanks at least monthly, if appropriate.
 - Failure to repair, replace or close the UST system if test results indicate that a release exists.
- The Application for Fund Eligibility is denied.
- The order became final June 6, 2025. The Respondent has until August 6 to correct the outstanding violations or there will be further enforcement actions.

- Violations in Order:
 - Failure to remove dispenser cover and visually inspect for releases, seeps, and drips at least quarterly.
 - Failure to perform periodic walkthrough inspections.
 - Failure to test line leak detectors annually.
 - Failure to conduct line tightness test on pressurized underground piping.
 - Failure to ensure that the cathodic protection system is tested every 3 years.
- Penalty:
 - Total fees and penalties: \$10,440.00.
 - The Order became final on May 15, 2025 and is currently in OGC.

Fac. ID No. 5-191335/ Porter Road Citgo, Nashville, Davidson County

- Fund Deductible Amount Order signed February 4, 2025.
- Violations in Order:
 - Failure to have spill prevention equipment that will prevent release of petroleum to the environment when the transfer hose is detached from the fill pipe.
 - Failure to perform periodic walkthrough inspections.
 - Failure to provide release detection method capable of detecting a release from tank that routinely contains product.
 - Failure to conduct annual line tightness test or do monthly monitoring on pressurized underground piping.
 - Failure to test line leak detectors annually.
 - Failure to maintain results of annual testing of electronic and mechanical components for three years.
 - Failure to cooperate with the Division.

- Fund Deductible Amount Order signed February 4, 2025.
- Violations in Order:
 - Failure to repair, replace or close the UST system and begin corrective action if test results indicate that a release exists.
 - Failure to successfully complete retraining.
 - The Fund Eligibility application is approved with a deductible of \$20,000.
- Penalty:
 - Total fees and penalties: \$3,200.00.
 - An Agreed Order was entered on March 31, 2025. The Respondent is to pay an upfront penalty of \$1,760.00 and have no probation violations for one year. A contingent penalty will be due if there is a violation during the year probation time.

 - Failure to operate and maintain corrosion protection system in accordance with a corrosion expert's design to provide continuous protection.
 - Failure to report a suspected release to the Division within 72 (seventy-two) hours.
- The Application for Fund Eligibility is denied.
- The order became final June 6, 2025. The Respondent has until August 6 to correct the outstanding violations or there will be further enforcement action.

 - Failure to test electronic and mechanical components at least annually.

 - Failure to install calibrate or maintain release detection method for piping in accordance with manufacturer's instructions.
 - Failure to report a suspected release to the division within 72 (seventy-two) hours.
 - Failure to repair, replace or close a UST system if test results indicate that a release exists.

 - Placing/causing to be placed, petroleum substances in a petroleum UST or to dispense petroleum from a petroleum UST when owner of tank is required to notify the Commissioner.

- The Order was appealed on May 22, 2025, and is currently in OGC.

 - There is no civil penalty assessed with this order.
- The case went final without appeal, no remedial action or civil penalty assessed, remediation case closed. Closing case.

 - The order went final with a 20k deductible. There were no remedial activities or civil penalties, and the remediation case is closed.

- Violations in Order:
 - Failure to provide release detection records for UST systems
 - Failure to report a suspected release within 72 hours.
- Penalty:
 - Total fees and penalties: \$34, 335.64.
 - An Agreed Order was entered on January 13, 2025. The Respondent is to pay an upfront penalty of \$34,335.64. Failure to comply could result in further enforcement actions. The Respondent paid the full amount of the cost recovery, and the case is now closed.

 - Failure to install, calibrate, operate, or maintain release detection method for tank in accordance with manufacturer's instructions.
 - The Application for Fund Eligibility is approved with a deductible of \$20,000.
- Penalty:
 - Total fees and penalties: \$4,400.00.
 - The order became final February 24, 2025, and is currently in OGC. The case is closed. The Respondent returned to compliance and paid the full civil penalty.

 - Failure to test line leak detectors annually.

 - Failure to submit the application for fund eligibility within ninety (90) days of the suspected release.
 - The Application for Fund Eligibility is denied.
 - The order became final on March 30, 2025, and is currently in OGC. The case is closed. No civil penalty or remedial action was required.

- Penalty:
 - Total fees and penalties: \$7,680.00.
- The Order became final February 24, 2025, and is currently in OGC. The Respondent returned to compliance and paid the full civil penalty, so the case is closed.

- The Order was appealed on November 18, 2024, and is currently in OGC. An Agreed Final order was reached. Respondent to pay \$2,280 in civil penalties and \$160 for SOP. \$4560 is contingent on one year probation.

- The Order was appealed on March 12, 2025, and is currently in OGC. Agreed Final order was reached. Respondent will pay \$1620 in civil penalties and \$160 in SOP. \$1920 is contingent on one year of probation.
