The Park has 37 rental cabins, a 145-site campground, bathhouses, a visitor's center/park office, outside restrooms, picnic shelters, and museum assembly hall.

Preferred candidates will be experienced in performing general custodial work of average difficulty, under general supervision, with duties such as sweeping, mopping, scrubbing, stripping, waxing, and buffing floors by hand or machine. This position involves working on weekends and holidays. A valid motor vehicle operator's license is required. Candidates must meet the minimum qualifications (MQs) for this position. ### Highlighted Responsibilities:

- Ensure the cabins and rental facilities are cleaned based on established standards and guidelines using proper equipment and cleaning supplies.
- Assist with laundering linens and bedding when needed.
- Clean restrooms by sanitizing showers, toilets, cleaning sinks, washing floors and walls, cleaning mirrors, and emptying trash.
- Patrol grounds to pick up trash and check for any other needed maintenance.
- Report daily maintenance needs to maintenance team regarding repairs needed for cabins and rental facilities.
- Ensure guest satisfaction by providing friendly interactions and satisfying their special requests.
