We provide an outstanding opportunity to work in a beautiful, natural work environment. This position is located at Edgar Evins State Park in Silver Point, TN. Edgar Evins is a park with a campground, cabins, group shelters, boat ramps, a guest dock, a swimming pool, and the park's office located in Silver Point, TN.

We are seeking candidates who have experience in facilities maintenance, grounds maintenance, and equipment maintenance. Preferred candidates will have the ability to repair a variety of small and large machinery and have a working knowledge of plumbing, electrical and mechanical repair. The position requires the ability to work on some weekends and holidays. The preferred candidate will have experience equivalent to three years of skilled full-time labor and trades work including at least two years in building, grounds work, heating, and refrigeration maintenance and/or equipment operations work. Highlighted Responsibilities:

- Operate a variety of tools including bulldozers, backhoes, tractors, bobcats, dump trucks, ditch witches, welders, cutting torches, chainsaws, and an assortment of lawncare equipment and hand tools.
- Perform logging operations; rewire electrical outlets and breaker boxes; perform minor construction projects, plumbing tasks; performs and landscaping. Assist with the building of displays.
- Perform basic welding as needed for repairs.
- Operate chainsaws according to manufacturer safety specifications.
- Support the general maintenance of park equipment used to perform the job. Sharpen mower blades, change mower oil and filters. Maintain and keep in good working condition.
- Complete minor janitorial duties.
