- Place orders for food supplies based on projected business levels and price from a variety of vendors. Ensure products ordered are correct and meet acceptable standards.
- Conduct regular food inventory reviews to minimize loss.
- Prepare shift schedules for kitchen staff based on projected business volume to effectively manage labor costs.
- Maintain food quality, food cost, service, cleanliness, safety, and sanitation standards.
