This position is responsible for leading the daily shifts in the kitchen, preparing meals for the food and beverage outlets, and banquet meetings. The preferred candidate will have knowledge of commercial kitchens and experience in high-volume restaurant operations. A ServSafe certification is required for this position within ninety days of employment. Candidates should be able to shift back and forth between two or more activities or sources of information (multitasking). It is a requirement of the position that a candidate is able to exert muscle force to lift, push, pull, or carry objects. The position requires work on weekends and holidays on a rotating basis. - Prioritize food prep tasks based on knowledge of the time needed to cook and prepare food items
- Maintain a clean and functional kitchen that exceeds the Department of Health expectations
