Day-use guests also utilize the trails for birding and wildlife viewing. Big Hill Pond and Travis McNatt Lake are used for paddling and fishing. Other popular attractions include the Dismal Swamp boardwalk, a 70-foot observation tower, an aviary, pickleball, basketball courts, playgrounds, picnic pavilions, and an 18-hole disc golf course. The park is perfect for nature enthusiasts to observe native wildlife, plants, and the natural ecological diversity of the area.

The preferred candidate will be comfortable working with diverse park guests and enjoys interpretive programming. - Provide Historical, Natural, and Educational Programs on and off the natural area during shift by scheduled and impromptu programming to meet the needs of the park and community.
