Are you looking for an opportunity to work with Tennessee State Parks? Our Tennessee State Parks are among the most beautiful parks in the United States. This position is at Paris Landing State Park in Buchanan, TN. The park consists of 1,126 acres located on the western shore of Kentucky Lake. The park offers camping, a 91-room Lodge with conference space, a restaurant, cabin rentals, a full-service marina, an 18-hole golf course, picnic shelters, and a nature center.

The preferred candidate will be comfortable working with diverse guests of our park, interacting with various wildlife, enjoying interpretive programming, and being willing to work towards protecting natural and cultural resources. The position requires the ability to work with a flexible work schedule, including evenings, weekends, and some holidays. To be considered for this position, you must have a bachelor's degree or preferred degree in resource management, history, or a natural resource-based field of study. ## Highlighted Responsibilities:

- Deliver high-quality interpretive programs and recreational experiences.
- Provide educational and volunteer opportunities within the park.
- Coordinate program requests and work with management to meet programming requirements.
- Guide seasonal interpretive staff in developing quality programming based on the park themes.
- Research and develop mission-based and site-specific exhibit content and program outlines.
- Support Park goals of resource protection and management in invasive removal, restoration of natural and cultural areas, and visitor education of resource significance.
- Support relationships and partnerships with community to increase park's program capacity.
- Responsible for oversight of Nature Center and staff.
- May be required to act as a medical responder and assist with search and rescue operations. Emergency Medical Responder training is required.
