This position is responsible for leading and performing overnight requirements associated with the front desk duties at the Pickwick Landing lodge. The preferred candidate will have knowledge and experience as a hotel front desk employee, working with property management systems for reservations, and experience working with groups in a hospitality environment. Education equivalent to High School diploma or equivalent plus 2 years of experience in a guest services role, preferably as a hotel front desk associate. ### Highlighted Responsibilities:

- Lead and assist completion of end of day shift requirements for the front desk operations at the lodge.
- Assist with training of the front desk staff to successfully perform front office overnight operational duties.
- Manage lodging accommodations using approved property management systems and cabin accommodations through Initio or approved point-of-sale system.
- Prepare and review end of day reports and transfer to central office.
- Ensure guest satisfaction by successfully resolving guest issues and handling evening guest requests.
- Help Lodge and Park guests with directions and explanation of local and Park attractions
