Air Pollution Control:

The Division implements the Tennessee Air Quality Act and delegated programs of the federal Clean Air Act, working to maintain the purity of Tennessee's air resources consistent with the protection of human health, general welfare and physical property of the people, maximum employment, and the full industrial development of the state. The Division serves 91 counties within Tennessee and oversees local air programs in Davidson, Hamilton, Knox, and Shelby counties. The Division operates an ambient monitoring network, provides air quality forecasting, establishes emission standards and procedural requirements for industries through the issuance of construction and operating permits, and ensures compliance by inspecting facilities and verifying compliance with issued permits or pursuing enforcement to ensure the facility returns to compliance in a timely manner.

Overview:

Looking for a great engineering career opportunity working for the Tennessee State government? Interested in protecting our environment, public health, and air quality? The Division of Air Pollution Control has an engineering position in our Central Office in Nashville, TN. The selected engineering candidate will work in the Composite Materials Section of the Permitting Program and will be the technical lead responsible for reviewing the quality and consistency of drafted permits such as True Minor, Conditional Majors, and Title V industries across Tennessee. We are seeking candidates who can work with a team of technical professionals to develop permitting standards, assist in developing a permit writer's training program, and ensure the completion of projects on various levels of complexity. This position requires excellent communication and organizational skills, a valid driver's license, and may require overnight travel.

The preferred candidate will have a bachelor's or master's degree in engineering and experience with federal and state air quality regulations. The position offers working in alternative workspaces such as your home and other state offices, but you will be required to report to the Nashville Central Office on an as-needed basis. Highlighted Responsibilities:

- Review stationary source applications for permit applicability.
- Review applicable federal and state regulations and apply these to draft permits as appropriate.
- Prepare construction and operating permits for stationary sources of air pollution at industrial entities, private businesses, and state facilities.
- Review and evaluate Maximum Achievable Control Technology standards for stationary sources.
- Help maintain a comprehensive database system.
- Work cooperatively and effectively with management, other division employees, and the public, to help issue accurate and enforceable permits.
- Meet critical deadlines and do follow-up on assignments with a minimum amount of directions.
