## TSP Maintenance Lead Cumberland Trail State Park Annual Salary Range: \$38,364 - \$57,648

The Cumberland Trail State Scenic Trail State Park became the 53rd State Park in 1998 and is one of the most beautiful and unique state parks in Tennessee. The Cumberland Trail is a scenic footpath which follows a line of high ridges and deep gorges along or near the rugged, eastern edge of Tennessee's Cumberland Plateau. The trail offers a unique wilderness experience and many scenic views, waterfalls, landscapes, gorges, wildlife, and widely varying flora.

The position will be responsible for overseeing TSP Maintenance staff, producing routine reports, and maintaining digital and/or physical records of work performed. Candidates should be able to carry tools, such as chainsaws, mattocks, and other equipment deep into the backcountry and complete trail maintenance. The preferred candidate will be able to do some regular building maintenance that may include plumbing, electrical, or carpentry. There are some opportunities for training on the job. ## **Highlighted Responsibilities:**

- Inspects grounds and facilities daily to identify areas or facilities needing repair and maintenance. Perform facility maintenance needs.
- Perform grounds maintenance work, including cutting and trimming grass and obstructive tree limbs.
- Operate a variety of maintenance equipment, including commercial zero turn mowers, weed eaters, backpack leaf blowers, chainsaws, and tractors.
- Perform routine maintenance and repair on equipment, vehicles, and tools to ensure equipment is maintained properly.
- Perform janitorial tasks related to cleaning facilities, such as trash removal, cleaning of restrooms and visitor center.
