
Dear Mr. Cox:

The Department of Environment and Conservation has not received the Solid Waste Planning Region Five-Year Update Report for the Anderson County Solid Waste Planning Region. The Solid Waste Management Act of 1991 [T.C.A. 68-211-814 (2)] requires that these reports be revised every five years after the plan's initial approval. The Anderson County report was due to the Division of Community Assistance on September 27, 2001.

The Region must submit the required report within 90 days of receipt of this letter. Otherwise, the region and jurisdiction(s) within the region may lose eligibility for grants from the Solid Waste Management Fund. If non-compliance continues, additional sanctions may follow [T.C.A. 68-211-816].

As you are aware, the Solid Waste Management Act of 1991 requires the Solid Waste Regions to plan, monitor, and report on solid waste activities. One of the requirements of this legislation was for each region to prepare a Ten-year Solid Waste Management Plan. The legislation also requires that Five-year updates to those plans be prepared and submitted to the state for review. The Anderson County Region's Ten-year plan was approved on September 27, 1996; therefore, your Five-year Update is due to this office by **September 27, 2001**. Please note that the Update is expected to consider the next Ten-year planning horizon, and will become your current Ten-year Plan upon approval by this office.

Also required by the Solid Waste Act is submittal of a Needs Assessment report for all of the counties within each Development District. The initial Assessment was due by September 30, 1992; with revisions due by April 1, 1999 and every five years after that. The SW Needs Assessment for the counties and municipalities within your region was received on January 5, 2000. Please contact Mr. Mitch Loomis with the East TN Development District to determine the status of your Region's Needs Assessment report. The Needs Assessment will provide much of the information necessary for the preparation of the Five-year Update to your Ten-year Plan.

### SUMMARY

The Anderson County Solid Waste Planning Region was established as a single county region in November 1992 and has continued to operate as a single county region. The region is made up of one county, Anderson, and five cities, Clinton, Lake City, Norris, Oak Ridge and Oliver Springs. Lake City lies in both Anderson and Campbell Counties; Oak Ridge lies in both Anderson and Roane Counties; and Oliver Springs lies in Anderson, Roane and Morgan Counties. The largest portion of all three of these cities lie within Anderson County. The City of Clinton is the County Seat.

An eleven - member board represents the Anderson County Solid Waste Planning Region. The planning region board was established under the guidelines of the Solid Waste Management Act of 1991. The Board meets quarterly on the fourth Tuesday to discuss solid waste issues and to set policies. The Anderson County Solid waste Planning Region has a director that oversees the day to day operation within the County and carries out policies set by the solid waste board and the County Commission.

The Anderson County Solid Waste Planning Region continues to meet their goals as laid out in the Ten Year Solid Waste Plan. Many of the activities established in the original ten - year plan have been implemented within the first five years.

**WASTE STREAM:** Residential Waste is the main type of waste collected in the Region. Approximately two-thirds of the waste generated comes from the residential sector. Industrial and Commercial Wastes consists of over one-third of the waste generated in the Region.

**COLLECTION and TRANSPORTATION:** The collection of solid waste is being met through a network of six (6) convenience centers by the county and door to door pickup by the cities. The Region utilizes two "Green Box" sites for the collection of residential waste in the remote sections of the county. The County would like to eliminate these two green box sites in the future, but the remote location of these sites make it difficult to justify a manned convenience center at the present time. It is the feeling of the Region that collection needs are being met and no new changes are being considered.

**RECYCLING / WASTE REDUCTION:** Solid waste reduction and recycling is being met through an integration of curbside pick-up and drop-off centers at convenience centers and other designated areas. No changes in the method of source reduction are being contemplated at this time. Composting is handled through the promotion of backyard composting bins. Approximately 1000 Home Composting Bins are in use throughout the Region. A breakdown of the materials recycled and their tonnages are provided in the appendix.

**DISPOSAL:** Disposal is being met in the Region by hosting a privately operated regional landfill with over 20 years of life left and additional land available for the future permitting of cells. Anderson County will renegotiate its waste contracts in year 2003. The Region's yearly Waste Disposal Tonnages received from Waste Management – Chestnut Ridge Landfill are as follows:

**PROBLEM WASTES:** The Region is pleased to participate in the State's Household Hazardous Waste Collection Program. Participation at these events has been well above the State's average participation rate. These events are held in the City of Oak Ridge in the Spring and in the City of Clinton in the Fall. In addition to the collection of the mandated problem waste (lead acid batteries, oil and waste tires), the Region also accepts antifreeze, oil filters and fluorescent light tubes. As an addition to our Region's problem wastes collection program, Anderson County Solid Waste Management began the collection and recycling of old refrigerators and freezers (white goods) for its citizens in July 2001. Anderson County participates in the State's Waste Tire Option Program. The County processes approximately 60,000 tires under Option 3 of this program.

**EDUCATION:** The Solid Waste Management Office offers waste reduction programs to schools, civic and community groups and Scouts. Most schools in the Region have an active environmental program for their students. The Region's Solid Waste Planning Board encourages the education of their citizens to solid waste issues.

**FLOW CONTROL:** Currently the Anderson County Solid Waste Planning Region makes no attempts to provide flow control and has no intentions to attempt flow control within the next ten years.

The regional implementation schedule, flow chart and proposed ten – year budget are shown in the appendix.

Anderson County's Solid Waste Planning Region feels that it has met the 25% Waste Reduction Goal even though past reports have shown that it has not. Our reasoning is that the disposal tonnages reported are from residential, industrial and commercial / institutional waste. Anderson County Region can only obtain the efforts of waste reduction, recycling and diversion tonnages that are only from our residential programs. The tonnage figures from the industrial, commercial and institutional sectors are very difficult to obtain by the Region.

**6. Briefly describe the activities and workings of the Region's Solid Waste Board**

The Anderson County Solid Waste Planning Region Board meets quarterly to develop, promote and review programs to meet the needs of citizens and the requirements of State and Federal laws. The Planning Region Board assigns responsibility to prepare and submit the Annual Progress Report and Solid Waste Plan. The Board meets its responsibility with regard to permit reviews, as it is needed.

**7. Describe the Region's rationale for formation. Is the current structure satisfactory?**

Anderson County elected to form a Single County Solid Waste Region in order to protect the interests of its citizens. Anderson County is host to one privately owned Class I landfill. Anderson County chose to remain a one county region in order to maintain clear control over the expansion, use and operation of landfills within its boundaries.

**9. Describe the Region, generally, geographically, and demographically.**

Anderson County is a single county solid waste region for the purposes of developing its Solid Waste Regional Plan. There are five (5) municipalities in the county: Clinton, Lake City, Norris, Oak Ridge and Oliver Springs. Lake City lies both in Anderson and Campbell Counties; Oak Ridge lies in both Anderson and Roane Counties; Oliver Springs lies in Anderson, Roane and Morgan Counties. The Region contains 345 square miles. The major physiographic features are the Clinch River; New River, a tributary of the Cumberland River; and Norris Lake. The Southwest two-thirds of the Region is in the Great Valley of East Tennessee, a part of the Valley and Ridge Province. The Northwestern third is in the Cumberland Mountains. The City of Oak Ridge is highly urbanized. Generally, its citizens are cosmopolitan, highly educated and compared to the east Tennessee area earn high per capita incomes. On the other hand, the New River area is a rural area with declining population, extremely low population density, and poverty level per capita income.

In response to your request of December 14, 2001, I can provide the following information:

1. The City of Clinton does not charge a fee for solid waste / refuse collection services. Residential and small business / commercial (equivalent to residential collection volumes) collections are funded through the City's General Fund. Small business / commercial collections that exceed the equivalent volume of a residential pick-up are charged directly for such excess volumes by our refuse collection contractor. Large commercial and industrial users are individually responsible for their own solid waste collection and disposal.
2. The costs for solid waste programs are included in the City's General Fund Budget. There is no revenue derived from the solid waste program. Disposal costs are included in the contract costs for refuse collection, and in accordance with previous agreements between the City of Clinton and Anderson County. With the exception of the Administrative Staff and the overall Public Works Department staff, there are no staff positions directly related to Solid Waste Management. The City of Clinton's Drop-Off Recycle Center is unmanned, and all other "waste reduction" activities that are not contracted are a part of the Public Works Department's overall mission.

In response to your recent correspondence, I offer the following:

1. Oak Ridge has implemented a charge to all residential units to defray some of the solid waste program costs from the property tax. A monthly \$5.00 per household fee is added to all residential utility bills and processed by the city's utility office. City Council implemented this fee in July 1998 as part of the annual budget preparation.
2. Oak Ridge contracts with BFI for residential refuse and recycling services. This includes collection and transport to the disposal facility. Tipping fees are provided through the Anderson County property tax paid by homeowners. In addition, BFI operates a convenience center in the City, as well as performs an annual spring trash and brush cleanup and a fall leaf collection. For the current fiscal year, the City pays BFI \$1,727,734 for these services. Additionally all brush collected in the spring and/or accepted at the convenience center year-round is mulched at the Knox County yard waste facility in Solway. This year, approximately \$52,000 is budgeted for the cost of this component of our program. Other costs for minor items in the program amount to \$47,000 annually for a total program cost of \$1,826,734. The \$5 surcharge generates approximately \$689,000 to meeting this expenditure with the remainder incorporated into the city's property tax rate. At present the City is satisfied with its program and the funding mechanisms to pay for it. No program enhancements are planned.
3. The city budget account number 998 identifies the monthly surcharge as a transfer into the general fund for the purpose of offsetting some of the solid waste program costs. A copy of this page is included.

4. The City's current contract with BFI runs through 2011. The city foresees the services delivered to remain essentially unchanged for the duration. The contract provides for an annual price adjustment equal to 90% of the annual CPI. Other program costs and required revenues are expected to be adjusted similarly.

**ACTIVITY DESCRIPTION**

The City of Oak Ridge is responsible for the collection and disposal of all residential solid waste within Oak Ridge. Services provided included the weekly collection of residential waste at the backdoor and at curbside for recyclable items, and a convenience center for disposing of large residential waste, recyclables and brush. Historically, solid waste management expenditures had been accounted for by the City in the General Fund. A 1992 revision in state law required the City to account for solid waste management in a separate Special Revenue Fund. This activity transfers funds from the General Fund to the Solid Waste Fund to support solid waste management expenditures. Fiscal 2002 is the fourth year of a ten year contract with Browning Ferris Industries (BFI) for residential waste collection with annual contract increases based on inflation. Refer to page IV-38 for a more detailed description of solid waste activities funded by this transfer.

A \$5 monthly fee is also included on each residential household's utility billing to fund a portion of the costs for solid waste collection. The \$60 per household annual fee generates approximately \$689,000 in revenues to the Solid Waste Fund. The City does not provide refuse collection for commercial entities.

- 5. Discuss any recent demographic trends that may affect waste disposal figures in the area. Are large groups of people moving into or out of the area for any special reason?**

The Region is experiencing a steady increase in population in the Norris and Glen Alpine districts of Anderson County but overall the County grew by less than 5% from 1990 to 2000. The Region is also experiencing a small increase in new businesses and industry start-ups, but no large manufacturing has moved into the Region that would generate significant amounts of waste. There are some businesses in the Region that produce small amounts of Special Waste, but volumes are not significant.

- 6. Discuss the economic condition of the County. Who are major employers? Is the unemployment rate high or low? What economic factors could affect the content and volume of the waste stream and waste reduction efforts in the County?**

The economic condition of the Anderson County Region is viable and trends indicate that the County is stable both in population and average yearly incomes. The unemployment rate is low. Job opportunities are available in a variety of occupations and industry, particularly the service industry. The major economic factor that could significantly impact the waste stream would be additional types of manufacturing plants built within the Region that would generate excessive amounts of waste by-products from the manufacturing process, such as a metal smelting facility. If this should occur, waste reduction efforts, disposal options and costs would need to be addressed. Currently the Region does not expect any significant impact. See attachment for major employers.

The contributors listed above represent known generators disposing waste in the Class 1 Landfill. There are several industries and businesses generating a significant amount of waste in the Region, however the Region does not know the amount of waste these businesses generate annually. Businesses privately contract for collection and disposal of their waste and most consider this to be proprietary.

The Code Enforcement Office manages the Tennessee Department of Transportation's Litter Grant Program in Anderson County. Complaints are the main way the litter pick-up is handled. Some general observance is also done. The education portion is handled through the Code Enforcement and Solid Waste Offices. Litter pick-up is done with the use of prisoners supervised by an officer with assigned roads and complaints.

- 9. Legislation passed by the General Assembly in 1999 adds consideration of an "economic growth adjustment formula" analysis for reporting solid waste disposal figures and progress toward the 25% waste reduction and diversion goal from year to year. The economic growth formula would include factors like growth rates, and taxable transactions in the Region, in addition to population changes. Does the Region perceive that this option would express progress on the State's 25% waste reduction goal in a more equitable fashion (a more fair representation of the Region's actual progress)?**

The economic growth adjustment formula of which includes factors like growth rate, employment rates, taxable transactions, and population formulas for the Region does not appear to enhance the reduction goal in a more equitable fashion for 1999 than by using the method of population ratio.

- 10. Use of a new base year (1995) and new goal year (2003) to achieve the 25% waste reduction and diversion goal are also in the 1999 legislation. Regions may provide documentation to adjust their 1995 base year figures for progress already made in ongoing reduction programs. Explain how the proposed base year change might affect your Region.**

There are no permanent household hazardous waste collection centers in the Region.

The household hazardous waste collection events are well received by the citizens of the Anderson County Region. Participation rates at these events have exceeded expectations. The Anderson County Solid Waste Management office receives calls daily to find out when the next event will be or how to dispose of a certain material responsibility. The Region is pleased with having these events twice a year. There are no immediate plans to support a local household hazardous waste collection facility in the Anderson County Region.

- 4. Describe the Region's efforts to see that waste tire collection mandates are met.**

Waste Tire collection is provided by Anderson County at the Blockhouse Valley Center. Anderson County operates this program under Option 3 of the Tennessee Department of Environment and Conservation's Waste Tire Program. Waste Tires are received and immediately loaded into trailers and sent to an end – use facility (cement plants for fuel).

**5. Discuss the Region's level of satisfaction with waste tire collection efforts in the area and the State waste tire program.**

The Anderson County Region is satisfied with the State's Waste Tire Program.

The Anderson County Region has a few remote (and difficult to access) areas where tires have been illegally dumped. Anderson County Solid Waste Management, Anderson County Litter Grant and a few private businesses and civic organizations have cleaned up a few of these sites. The Region feels the illegal dumping of tires has subsided since there is an outlet that provides for the responsible disposal of these waste tires and the education of the County's citizens.

**7. Describe the Region's efforts to see that oil and auto fluid collection sites mandates, and lead acid battery collection site mandates, are met. List the site(s) available. To meet and to exceed the requirements of the State, Waste Oil and Lead Acid Batteries are collected at four (4) Anderson County Convenience Centers. In addition to these materials Anderson County accepts oil filters and antifreeze. This service is available for all Anderson County citizens. These sites are: Glen Alpine Convenience Center, Green Valley Convenience Center, Marlow Convenience Center and Wolf Valley Convenience Center.

The Cities of Norris and Lake City accepts Waste Oil at their drop-off centers. The City of Oak Ridge accepts Waste Oil and Lead Acid Batteries at their drop-off center.





**WHEREAS**, the adoption of the Subtitle D landfill regulations by the United States Environmental Protection Agency and companion regulations adopted by the Tennessee Solid Waste Control Board will impact on both the cost and method of disposal of municipal solid waste; and

**WHEREAS**, at the urging and support of a coalition of local government, environmental, commercial, and industrial leaders, the 97th Tennessee General Assembly enacted T.C.A. 68-211-801 et seq. titles "Solid Waste Management Act of 1991"; and

**WHEREAS**, with the view that better planning for solid waste will help control the additional costs that will be imposed by the new landfill regulations, help protect the environment, provide an improved solid waste management system, better utilize our natural resources, and promote the education of the citizens of Tennessee in the areas of solid waste management including the need for and desirability of reduction and minimization of solid waste, local governments in Tennessee supported and work for the passage of this Act; and

**WHEREAS**, one of the stated public policies of this Act is to institute and maintain a comprehensive, integrated, statewide program for solid waste management; and

**WHEREAS**, as per T.C.A. 68-211-811 the nine development districts in the State of Tennessee have completed a district needs assessment which are inventories of the solid waste system in Tennessee; and

**WHEREAS**, Anderson County's Board of County Commissioners has given consideration to the needs assessment prepared by the East Tennessee development district; and

**WHEREAS**, T.C.A. 68-211-811, requires that counties in the State of Tennessee form municipal solid waste regions no later than December 12, 1992; and

**WHEREAS**, the Act's stated preference is the formation of multi-county regions with counties having the option of forming single or multi-county municipal solid waste regions; and

**WHEREAS**, the State of Tennessee will provide grant monies of varying amounts to single county, two county, and three or more county municipal solid waste regions to assist these regions in developing their municipal solid waste region plans; and

**WHEREAS**, the primary and prevailing purpose of the municipal solid waste regions are the preparation of municipal solid waste regional plans which among other requirements must identify how each region will reduce its solid waste disposal per capita by twenty-five percent (25%) by December 31, 1995, and a planned capacity assurance of its disposal for a ten (10) year period; and

**WHEREAS**, the development of a municipal solid waste regional plan that results in the most cost effective and efficient management of municipal solid waste is in the best interest of the citizens of Anderson County.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of County Commissioners of Anderson County, Tennessee, acting pursuant to T.C.A. 68-211-801 et seq., that there is hereby established a Municipal Solid Waste Region for and by Anderson County, Tennessee; and

**BE IT FURTHER RESOLVED**, that pursuant to T.C.A. 68-211-813(a)(2), that the Board of County Commissioners of Anderson County, Tennessee finds and determines that Anderson County shall be and shall constitute a single county municipal solid waste region due to the following; Anderson County is host to two regional landfills and in order to protect the interests of the citizens of Anderson County, Tennessee it is strongly felt that the Anderson County officials should have control over landfill operations within our county; and

**BE IT FURTHER RESOLVED**, that pursuant to T.C.A. 68-211-813(b)(1), a Municipal Solid Waste Region Board is hereby established to administer the activities of this Region; and

**BE IT FURTHER RESOLVED**, that this Municipal Solid Waste Region Board shall be composed of eleven members; and

**BE IT FURTHER RESOLVED**, that pursuant to T.C.A. 68-211-813(b)(1) six Board members shall be appointed by the County Executive and approved by the this Board of County Commissioners and due to the fact that City of Oak Ridge collects or provides disposal services through its own initiative or by contract, the City of Oak Ridge shall have a Board member appointed by the Mayor of Oak Ridge and approved by the City Council of Oak Ridge; and due to the fact that City of Norris collects or provides disposal services through its own initiative or by contract, the City of Norris shall have a Board member appointed by the Mayor of Norris and approved by the City Council of Norris; and due to the fact that Town of Lake City collects or provides disposal services through its own initiative or by contract, the Town of Lake City shall have a Board member appointed by the Mayor of Lake City and approved by the Board of Alderman of Lake City; and due to the fact that City of Clinton collects or provides disposal services through its own initiative or by contract, the City of Clinton shall have a Board member appointed by the Mayor of Clinton and approved by the City Council of Clinton; and due to the fact that Town of Oliver Springs collects or provides disposal services through its

own initiative or by contract, the Town of Oliver Springs shall have a Board member appointed by the Mayor of Oliver Springs and approved by the Board of Alderman of Oliver Springs; and

**BE IT FURTHER RESOLVED**, that members of the Board of the Municipal Solid Waste Region shall serve a six (6) year term except that two members appointed by the County Executive shall have a two (2) year term, that two members appointed by the County Executive shall have a four (4) year term, two that members appointed by the County Executive shall have a six (6) year term, that one member appointed by the Mayor of Oak Ridge shall have a four year term; and that one member appointed by the Mayor of Norris shall have a four year term; and that one member appointed by the Mayor of Lake City shall have a two year term; and that one member appointed by the Mayor of Clinton shall have a six year term; and that one member appointed by the Mayor of Oliver Springs shall have a two year term; and

**BE IT FURTHER RESOLVED**, that this Municipal Solid Waste Region Board shall have all powers and duties granted it by T.C.A. 68-211-813 et seq. and in addition, in the performance of its duty to produce a municipal solid waste region plan, it shall be empowered to utilize existing Anderson County governmental personnel, to employ or contract with persons, private consulting firms, and/or governmental, quasi-governmental, and public entities and agencies and to utilize Anderson County's services, facilities and records in completing this task; and







In response to your letter regarding additional information and or further clarification for Anderson County's Five-Year Update to the Solid Waste Plan, Anderson County Solid Waste Management offers the following.

### **Chapter 3. Waste Stream Section 11 Jurisdictions in Region Working Together**

The cities in the Region provide waste reduction programs and services for their jurisdictions only.

Representatives from each of the cities, county commission and citizens of Anderson County constitute the Anderson County Solid Waste Planning Region Board. This Board meets to discuss solid waste reduction programs and activities that are existing and proposed in this Region.

The majority of these jurisdictions work with the Anderson County Solid Waste Management Office to disseminate information to their citizens for new and existing programs being offered by Anderson County.

## **Chapter 6. Disposal**

### **Section 1**

#### **Where Gas is Transferred to.**

Chestnut Ridge Landfill, a landfill that is also a Gas Recovery Facility, converts buried garbage into electricity for East Tennessee. Methane is captured, processed then piped to the Recovery Facility where the gas is mixed with oxygen to provide fuel for engines for continuous combustion. These gas engines provide 1.9 million kilowatts electricity / hr to the Knoxville Utility Board.

## **Chapter 10. Five Year Plan Update Review**

### **Section 1**

#### **Public Hearing Comments**

In order to meet the requirements of the Solid Waste Management Act of 1991, a Public Hearing on the Five-Year Update to the Anderson County Regional Solid Waste Plan was held on January 22, 2002. This Public Hearing was held prior to the Anderson County Board of County Commissioners meeting. Also a copy of this Update was on file at the office of the Anderson County Commissioners previous to the Public Hearing for public inspection and review. A Public Hearing Notice was run in the area newspapers.

In attendance at this Public Hearing were County Commissioners, newspaper reporters and staff. A summary of this Update was distributed to those in attendance.

No comments were received regarding this Update. The Director of Solid Waste Management of Anderson County received favorable comments from the County Commissioners regarding his work and programs presented.

One of the requirements of this legislation was for each region to prepare a Ten-year Solid Waste Management Plan. The legislation also requires that Five-year updates to those plans be prepared and submitted to the state for review. The Anderson County Region's Ten-year plan was approved on September 27, 1996; therefore, your Five-year Update is due to this office by **September 27, 2001**. Please note that the Update is expected to consider the next Ten-year planning horizon, and will become your current Ten-year Plan upon approval by this office.

Also required by the Solid Waste Act is submittal of a Needs Assessment report for all of the counties within each Development District. The initial Assessment was due by September 30, 1992; with revisions due by April 1, 1999 and every five years after that. The SW Needs Assessment for the counties and municipalities within your region was received on January 5, 2000. Please contact Mr. Mitch Loomis with the East TN Development District to determine the status of your Region's Needs Assessment report. The Needs Assessment will provide much of the information necessary for the preparation of the Five-year Update to your Ten-year Plan.
