The Milan Army Ammunition Plant is providing notice of the recognition of Class ¹1 Modifications in accordance with Tennessee Hazardous Waste Management Rule 0400-12-01-.07(9)(c) for Permit Numbers TNHW-152 and 153 for the Milan Army Ammunition Plant.

Permit Number TNHW-152:

A Class ¹1 Permit Modification was submitted and recognized by the Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management to modify Attachment 8 "Closure Plan" to provide more detail than what is in the permit. The revised closure plan is for 14 hazardous waste storage magazines, Building J-137, and the Explosives Waste Transfer Facility.

This modification was effective July 12, 2022.


Permit Number TNHW-153:

The revised closure plan is for the Open Burn Unit and Open Detonation Unit.
