Milan Army Ammunition Plant is providing notice of the implementation of a Class ¹¹ Modification in accordance with Tennessee Hazardous Waste Management Rule 0400-12-01-.07(9)(c)5(i) for Permit Number TNHW-152 for the 14 Earth-Covered Storage Magazines, Building J-137, and Explosive Waste Transfer Facility, located on 2280 Highway 104 W in Milan, Tennessee, Gibson/Carroll County.

A Class ¹¹ Permit Modification was submitted to the Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM) on January 22, 2024. The Class ¹¹ Permit Modification included the following modifications to Permit Number TNHW-152:

- The Closure Plan, Attachment 8, has been updated to utilize the Arsenic Soil Screening Level for background of 10.06 mg/kg as provided in the “Fluor Daniel, Inc. (FDI) OU5 Southern Study Area Remedial Investigation (RI) (1996).
- The Closure Plan, Attachment 8, has been updated to remove the Total Organic Carbon (TOC) analytical test method for soils samples at Building J-137 and for the decontamination waters at Building J-137.
- The Closure Plan, Attachment 8, has been updated to remove the Total Organic Carbon (TOC) analytical test method for soils samples at the Explosive Waste Transfer Facility (EWTF) and for the decontamination waters at the EWTF.
- The Closure Plan, Attachment 8 (Pages 29 and 30) has been updated to reflect that residential Regional Screening Levels (RSLs) will be used as the decontamination or clean criteria to meet for each permitted storage unit. This includes an update to the Site-specific background soil value for arsenic of 10.06 mg/kg.

The modification was effective April 8, 2024.
