Subject: Class 2 Permit Modification

On January 14, 2025, Eastman plans to submit to the Tennessee Department of Environment and Conservation, Division of Solid Waste Management (DSWM) a request for a Class 2 permit modification in accordance with Rule 0400-12-01-.07(9)(c)5(ii) to modify Hazardous Waste Management Permit TNHW-185 to remove the requirement for a flame arrester on Hazardous Waste Storage Unit Number 10 (HWSU-10), HWSU-11, HWSU-12, and HWSU-13, and is requesting modification of Table 4-5 (General Inspection Schedule HWSU-22, -23, and -33) to require containers in Permit TNHW-185 be placed on a base sloped to drain.

Eastman is authorized by Hazardous Waste Management Permit TNHW-185 to store pumpable hazardous waste in Tank AA-01 (HWSU-10), Tank AB-01 (HWSU-11), Tank AC-01 (HWSU-12), and Tank AD-01 (HWSU-13). In compliance with Rule 0400-12-01-.06(10)(i)1(ii) Special Requirements for Ignitable or Reactive Wastes, the tanks are equipped with a conservation vent and an inert gas blanket provided by a site-wide, dedicated nitrogen distribution system. An Occupational Safety and Health Administration (OSHA) Process Hazard Analysis (PHA) revalidation determined that a flame arrester is not required for tanks so equipped.

As in accordance with Rule 0400-12-01-.07(9)(c)5(ii) the public comment period shall run from January 14, 2025 – March 22, 2025. Eastman Chemical Company will conduct a public meeting to provide information regarding the removal of the flame arrestors from HWSU-10, HSWU-11, HWSU-12, and HWSU-13. The meeting will be held on Tuesday, February 25, 2025, at 6:30 p.m. in Conference Room Number 112 of the Toy F. Reid Employee Center, located at 400 South Wilcox Drive, in Kingsport, TN.
