Industrial Technologies and Services, LLC, located at 2003 South Roan Street, Johnson City, Tennessee 37601 submitted a Class 2 modification to the Division of Solid Waste Management, Hazardous Waste Management Program, Hazardous Waste Permitting section located at the Davy Crockett Tower, 7th Floor, 500 James Robertson Parkway, Nashville, TN 37243 on March 31, 2025. As per Tennessee Hazardous Waste Rule 0400-12-01-.07(9)(c)(5)(ii), the Class 2 modification must specify changes being made to the permit and identify the requirements for Class 2 modification submissions. The Class 2 modification to Permit Number TNHW-167 for Thomas Industries, Inc, located on 2003 South Roan Street, Johnson City, Tennessee 37601, Washington County was approved on August 12, 2025. The permit modification updated the name of the Permittee and Owner/Operator from Gardner Denver, Inc. to Industrial Technologies and Services, LLC. The modification updates the following information:

- Changed Permittee and Owner/Operator on Hazardous Waste Management Permit from “Gardner Denver, Inc.” to “Industrial Technologies and Services, LLC”;
- *Section V. Specific Conditions for Corrective Action, Page V-12*, updated the address for the Division of Solid Waste Management from “William R. Snodgrass Tennessee Tower” to “Davy Crockett Tower”;
- *Attachment 1. Site Description, Page 8*, added a section to discuss the permittee’s ownership changes in relation to this permit modification and added a reference for the DSWM address change from William R. Snodgrass Tower to Davy Crockett Tower;
- *Attachment 5. Post-Closure Plan, Section X. Permit Maintenance, Page 5-3*, replaced “Gardner Denver” with “Industrial Technologies and Services, LLC”;
- *Attachment 6.3 Sampling and Analysis Procedures, Cover Page*, removed “Gardner Denver, Inc.’s”.
