# **Tennessee Sustainable Spirits**

This initiative supports distilleries, wineries, and breweries that adopt environmentally friendly practices through certification as a "Tennessee Sustainable Spirit". While producers benefit from guidance and recognition, consumers play an essential role by supporting these sustainable businesses.

So, how can you identify a sustainable producer? Here are some key factors to look for:

- 1. <u>Energy and Water Conservation</u>: Producing spirits can use significant energy and water, but sustainable producers take steps to minimize their consumption. Look for companies using renewable energy sources, energy-efficient equipment, or advanced water recycling systems/practices.
- 2. <u>Waste Reduction</u>: Sustainable producers aim to minimize waste. Whether it's composting leftover grains, reusing barrels, or reducing packaging waste, these practices show a commitment to environmental responsibility.
- 3. <u>Local Ingredients</u>: Many sustainable producers source their ingredients locally. This supports nearby farmers and reduces the carbon footprint of transporting raw materials. When choosing spirits, look for labels or descriptions that highlight local sourcing.
- 4. Look for the Tennessee Sustainable Spirits Logo: The TNSS logo identifies that the facility you are visiting has committed to becoming a recognized sustainable producer. Other certifications such as LEED (Leadership in Energy and Environmental Design) or USDA Organic demonstrate a producer's commitment to sustainable practices. Many producers also share their sustainability goals and progress online, offering transparency to consumers.

By choosing spirits from producers who prioritize sustainability, you're not just enjoying a high-quality beverage—you're also supporting businesses that care about the environment. Programs like Tennessee Sustainable Spirits make it easier to identify these eco-friendly options, ensuring your drink of choice contributes to a greener future. Next time you raise a glass, make it a sustainable one!


