Upcoming Events Energy Tips Material ReUse



The Tennessee Multi-Sector General Permit (TMSP) authorizes industrial stormwater discharges to waters of the State of Tennessee from industrial facilities. The TMSP expires on June 30, 2025 and the Tennessee Department of Environment and Conservation (TDEC) has prepared a replacement permit and published the draft for public comment. This draft permit is subject to change prior to the final issuance. If your facility currently has TMSP coverage, you do not have to do anything as of right now.

The Notice of Intent (NOI) form via My TDEC Forms will be sent to active permittees when the new permit is issued. If your facility does not have coverage under the previous TMSP and operations will begin before June 30, 2025, your facility will need to submit a completed NOI and stormwater pollution prevention plan (SWPPP). <u>TVA EnergyRight</u> offers various types of support for business and industry partners, including energy efficiency incentives, revitalization programs, and strategic energy management. TVA provides no-cost <u>energy assessments</u> to customers with an electrical demand of 1,000 kW and greater to identify and quantify incentive-eligible energy efficiency projects.

For industrial customers with an electrical demand of 3,500kW and greater, TVA and its LPCs offer the <u>Strategic Energy Management</u> program, which lasts two years and helps qualifying industrial customers increase profitability and achieve sustainability goals by reducing energy use and lowering carbon emissions. The program provides energy performance modeling, energy mapping, onsite engineering studies, and individualized monthly coaching, all tailored to help eliminate energy waste.

## MATERIALS REUSE

Volkswagen of Chattanooga has been a Tennessee Green Star Partner since 2020 and a



leader in sustainability worldwide for much longer.

A recent significant expansion of the facility to manufacture their new electric vehicle line led to an immense amount of wooden pallets. The OSP Business Team facilitated a reuse project with Rockwood Recycling. The pallets were ground up onsite and most of the material was used as boiler fuel at a separate facility in Georgia. Over **300 tons** of pallet material was diverted from the landfill.
