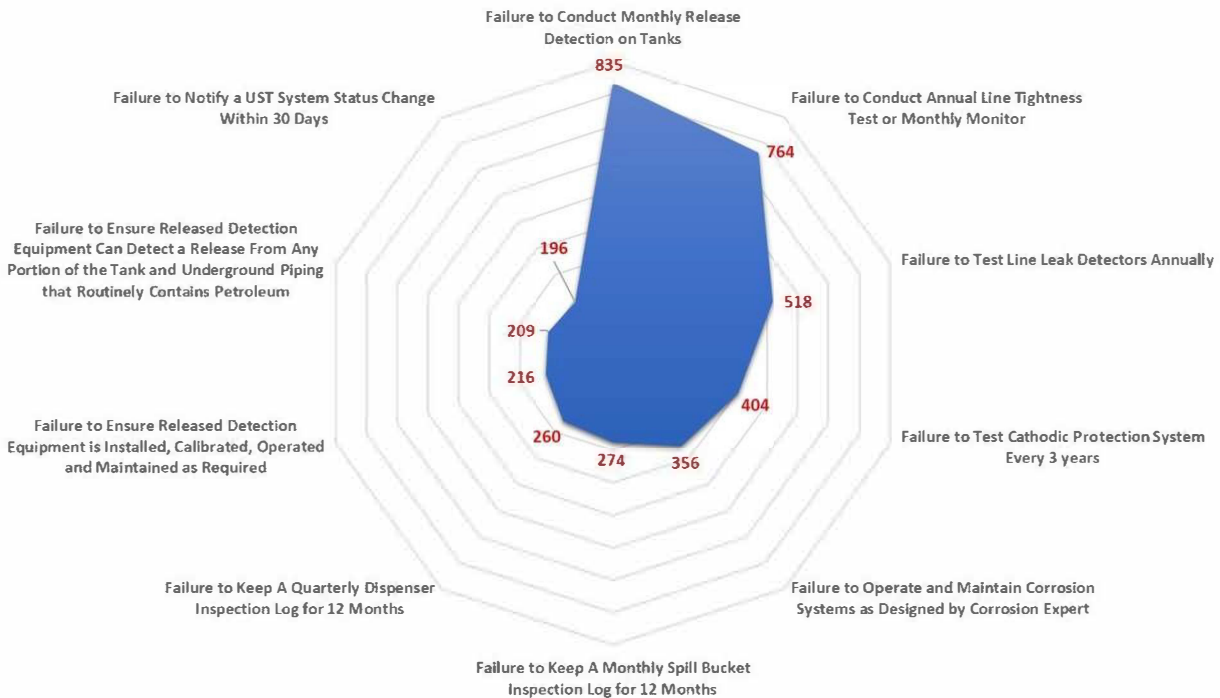
Top Ten Statewide Operational Compliance Violations

The violations listed above are the most cited violations during operational compliance inspections in The State of Tennessee. The top two violations are failure to conduct monthly release detection on tanks and failure to conduct a line tightness test or monthly monitoring on pressurized piping.
