What is Tank School?

The Tennessee Tank School class provides a classroom learning opportunity to earn a petroleum underground storage tank (UST) Class A and Class B operator certificate. UST owners/operators are required to designate trained operators under Tennessee's petroleum UST regulations. Tennessee Tank School is designed to:

- Increase tank owners and operators' understanding of regulatory compliance with the Tennessee petroleum underground storage tank rules,
- Prepare owners and operators for future operational compliance inspections, and

• Keep owners and operators knowledgeable of all current Tennessee petroleum UST regulatory requirements.

This course covers UST systems equipment, UST systems operational and testing requirements, all recordkeeping and reporting requirements, and up-to-date and relevant information about the Tennessee UST Program. Attendees who complete the entire class and score 70 or above on the class final exam earn a Class A and B Operator Tennessee Certificate.

Why is Operator Training Important?

Tennessee Tank School is provided for our mutual continued efforts in achieving compliance with Tennessee's Rules and Regulations that are designed to ensure the proper storage of petroleum in underground tank systems throughout the state. The primary goals are to improve operational compliance, prevent petroleum releases from occurring, remediate petroleum releases quickly to reduce product loss, avoid expensive cleanups, and lessen environmental impact. Ultimately, this makes Tennessee a better place to live, work, and play.
