Permanent Closure of UST Systems

Steps to Closing Your UST Tank & Piping Systems

- Submit Permanent Closure Application (PCA) to Closure. Application. UST@tn.gov.
 - An approved copy of the PCA must be available onsite during all closure activities.
 - ALL applications must be approved prior to beginning any site closure activities.
 - o Division approval of the Application for Closure of Tank Compartment(s) is only valid for 12 months from the date of approval. Also, the approval cannot be transferred to another person during that 12-month approval time.
- Contact the Division at least one working day prior to implementing any closure or sampling activities.
- If laboratory results show contamination levels exceed Initial Screening Levels (ISLs) at closure, report to the Division at Releases.UST@tn.gov within 72 hours and submit a fund application to UST.Fund@tn.gov within 60 days of confirmed release.
 - All Fund eligible work shall be conducted and/or overseen by a UST Approved Corrective Action Contractor.
- Submit a Permanent Closure Report (PCR) and sample results to the Division within 60 days of sample collection.



What Information is Required for Your PCA?

- Tank number, including size and product type and date last used
- Piping material, trench length, and product type
 - All piping trenches must be numbered
- · Dispenser number, products dispensed, and date last used
- Detailed site map
 - The application will not be processed without a complete site map.
- Laboratory name for sample analysis
- Company / person performing the UST system closure
- Company / person obtaining soil / water samples
- Management of excavated material
- Management of contaminated soil and/or water

*NOTE: In selecting sample types, sample locations, and measurement methods, owners, operators, and/or other responsible parties shall consider the method of closure, the nature of the stored substance, the type of backfill, the depth to groundwater, and other factors appropriate for identifying the presence of a release.
