

Public Notice Tennessee Department of Environment and Conservation (TDEC) Division of Water Resources (DWR) Notice Requesting Public Comments on Draft Permit Actions FILE # NRS25.069

The purpose of this notice is to advise the public of the following proposed permit action and solicit comments and information necessary to evaluate the potential impact of the proposed activities on the aquatic environment.

Pursuant to The Tennessee Water Quality Control Act of 1977, T.C.A. §69-3-108 and Tennessee Rules, Chapter 0400-40-07, the proposed activity described below has been submitted for approval under an Aquatic Resource Alteration Permit and Section 401 Water Quality Certification. Section 401 of the Clean Water Act requires that an applicant obtain a water quality certification from the state when a federal permit is required. This notice is intended to inform interested parties of this permit application and draft permit and rationale, and to ask for comments and information necessary to determine possible impacts to water quality. At the conclusion of the public notice period a final determination will be made whether to issue or deny the permit.

LOCATION

Peakland Road and T. Dake Road, Ten Mile, Tennessee Unnamed wetlands and tributaries to Watts Creek, Watts Creek Latitude 35.634120, Longitude -84.758201, Ecoregion 67f, impacts in Lower TN River watershed

PROJECT DESCRIPTION / PURPOSE

Stream Mitigation Development, LLC proposes to develop a stream and wetland compensatory mitigation bank. Impacts include approximately 11,860 linear feet of Watts Creek and 15 of its unnamed tributaries using natural channel design techniques to provide a functional lift capable of restoring natural channel hydrology, hydraulic, geomorphic, physicochemical, and biological characteristics. In addition, 2,576 linear feet of stream will be enhanced through bank stabilization and woody debris installation efforts, and 3,341 linear feet will receive preservation treatments. In addition to the above stream treatments, 36.20-acres of vegetation enhancement and 7.78-acres of vegetation preservation will provide additional buffer for aquatic resources at Watts Creek Mitigation Bank. No mitigation is required.

ANTIDEGRADATION

The affected waters have unavailable parameters for habitat. As described in the accompanying permit rationale, the Department has made a preliminary determination that the proposed activity will result in no signification degradation.

FACTORS CONSIDERED

In deciding whether to issue or deny this permit, the Division will consider all comments of record and the requirements of applicable federal and state laws. The division will consider the nature, scale and effects of proposed impacts. The Division will consider practicable alternatives to the alteration, loss of waters or habitat, diminishment in biological diversity, cumulative or secondary impacts to the water resource, and adverse impacts to unique, high quality, or impaired waters.

In making this decision, a final determination will be made evaluating appreciable permanent loss of resource values and proposed compensatory mitigation to ensure the project will not result in no overall net loss of state water resources values.

HOW TO COMMENT

TDEC is requesting public comment on this proposed permit action. Obtaining a broad range of facts and opinions on Agency actions is one of the best ways to ensure appropriate decisions. Persons wishing to comment on the proposal are invited to submit written comments to the Division. Written comments must be received within **thirty days following distribution of the approved public notice materials** (including signage and newspaper ad). Comments will become part of the record and will be considered in the final decision. The applicant's name and permit number should be referenced. Send all written comments to the Division's address listed below to the attention of the permit coordinator. You may also comment via email to <u>ARAP.permits@tn.gov</u>.

After the Division makes a final permit determination, a permit appeal may be filed by the applicant or by any person who participated in the public comment period whose appeal is based on comments given to the Division in writing during the public comment period or in testimony at a formal public hearing. PUBLIC HEARING

Interested persons may request in writing that the Division hold a public hearing on this application. The request must be received by the Division within the comment period, indicate the interest of the party requesting it, the reason(s) a hearing is warranted, and the water quality issues being raised. When there is sufficient public interest in water quality issues, the Division will hold a public hearing in accordance with 0400-40-07-.04(4) (f). Any scheduled public hearings will be advertised through a similar public notice process.
