Tennessee Department of Transportation (TDOT) proposed emergency

replacement of two existing damaged timber bridges along Forked Deer

Road/State Route 180 over Lost Creek and the Overflow to Lost Creek with two single span bridges to meet current design standards. The project requires permanent impacts to 83 feet of an unnamed tributary of the Overflow of Lost Creek (STR-1 – relocation/fill). The construction will include the removal of the existing 3-span timber bridge over the Overflow of Lost Creek (STR-2) for a single span 36" box beam bridge 29.25 feet in length over the stream. The project

will also include the removal of the existing 5-span timber bridge over Lost Creek (STR-1) for a single span 54" bulb-tee beam bridge 29.25 feet in length. Additionally, the construction of the project will permanently impact 0.07 acres of WTL-1 and temporarily impact 0.14 acres of WTL-1. Stream mitigation will be provided thru the purchase of 85.5 functional feet credits from Jack's Creek
