The following Departments were invited in individually to review their audit findings and explain the associated actions that have been taken or will be taken to remedy these findings: Tennessee Human Rights Commission and Tennessee Community Services Agency. The following state entities were unable to present and review their findings to the ISC due to time constraints: Tennessee State Veterans' Homes Board, Tenne ssee Advisory Commission on Intergovernmental Relations, and Tennessee Board of Regents Institutions. ISC members recommended meeting on January 11<sup>th</sup> 2017 in order to complete these audit briefings.
