This is a reminder that, starting September 1, 2018, the Tennessee Department of Financial Institutions will begin using the Nationwide Multistate Licensing System ("NMLS") to manage all licenses under the Tennessee Check Cashing Act. Through NMLS, your company will be able to apply for, amend, and renew its license(s) conveniently and safely online. The purpose of this notice is to remind you of important information to help you prepare to use NMLS. NMLS is a secure web-based system created by state regulators to provide efficiencies in the processing of state licenses and to improve supervision of state-regulated industries. Through NMLS, companies maintain a single record which they use to apply for, maintain, renew, and surrender license authorities in one or more states. NMLS also contains functionality for the submission of financial statements and credit reports as required for a check casher license.

## **NMLS Training**

NMLS is owned and operated by the State Regulatory Registry LLC (SRR), a wholly owned subsidiary of the Conference of State Bank Supervisors (CSBS). To help with the transition, SRR will conduct a live webinar intended to assist licensees in transitioning their existing company and branch licenses onto NMLS.

The webinar will be held on Thursday, August 30, 2018, from 1:00 pm – 2:30 pm CDT. You may register for the webinar by means of the following link:

This training is intended to assist Check Casher licensees transition their existing company and branch licenses onto NMLS. This training session will include a review of the state specific requirements and a system demonstration of requesting a license. We encourage licensees to participate in this training for a smooth transition onto NMLS.

In preparation for this training session, licensees new to NMLS are encouraged to complete the prerequisite course - **NMLS New User Training: MSB, Debt and Consumer Finance** - located in the CSBS Learning Management System (LMS). This course is free of charge and can be accessed by logging into your account in the CSBS Learning Management System. If you do not have an account, access
