

# REQUEST FOR QUALIFICATIONS

The Town of Mountain City is seeking Qualifications for Engineering Services – Asset Management Plan. Requirements are focused on experience in the development of an Asset Management Plan encompassing the water and wastewater systems. Qualifications must be received by the City Recorder at the Town of Mountain City, 210 S Church Street, Mountain City, Tennessee, 37683, by May 22, 2024, at 4 p.m. Electronic or printed Statement of Qualifications are accepted.

The successful firm must comply with grant-related rules, regulations, and requirements as applicable. An Asset Management Plan is being requested to adhere to Tennessee Department of Environment and Conservation (TDEC) guidance related to the American Rescue Plan (ARP) grant funding. The Asset Management Plan will need to be completed by July 2026.

## **ENGINEERING SERVICES**

Components of the Asset Management Plan include, but are not limited to:

- o Current State of Assets Inventory and Condition Assessment
- Level of Service
- Critical Assets
- Minimizing Life Cycle Costs Capital Improvement Plan
- Long-Term Funding Plan Rate Evaluation
- Meter Testing and Changeout Program
- IT Infrastructure
- Work Order System

## **Background**

The Town of Mountain City (the Town) has an approximate population of 2,500 and lies within Johnson County having a population of approximately 20,000. The Town operates a 3.0 MGD wastewater treatment plant, a collection system that includes approximately 27 miles of gravity sewer, 15 miles of sewer force main and 10 lift stations which serve the Town and the Northeast Correctional Complex. The Town operates three water treatment plants, 14 booster pumping stations, 13 water storage tanks and approximately 187 miles

of waterlines serving 4,000 customers and 1,800 inmates and staff at the Northeast Correctional Complex.

## **ENGINEERING SERVICES DESCRIPTION**

The Town has an immediate need for the development of an Asset Management Plan that is a requirement to receive America Rescue Plan funding managed by the Tennessee Department of Environment and Conservation (TDEC). TDEC has provided guidance for the preparation of the Asset Management Plan. The firm must be familiar with and prepare the plan in conformance with TDEC requirements.

Respondents will be evaluated based on written materials submitted according to the factors listed below. Therefore, the Statement of Qualification submitted should include information documenting:

- Specialized/technical experience of the firm regarding creation of Asset
  Management Plans components 40 Points
- Capacity of the firm to complete the Asset Management Plan within the grant timeline, taking into consideration the firm's current and planned workload – 30 Points
- Firm's familiarity with a similar community's needs 20 Points
- Firm's project completion background and references 10 Points
  Maximum Total Points 100
